The Deputy Minister for Agriculture, Food, Fisheries and European Programmes (Alun Davies): To meet the eligibility criteria for option 37 of the All Wales Element (AWE) of Glastir, cattle breeds must be recognised by the Member State in accordance with Community zootechnical legislation and the number of breeding females must be below the threshold set by Annex IV of Commission Regulation (EC) No 1974/2006 i.e. 7,500 breeding cows available for pure-bred reproduction (and registered with an approved breeding organisation). Any number above this results in the breed being deemed to be not at risk. Welsh Blacks are recognised as a breed on the zootechnical list but the last authoritative estimate of numbers by the Farm Animal Genetics Resources (FAnGR) National Standing Committee shows that there are 9,412 Welsh Black breeding females available for pure-bred reproduction. This estimate was derived from data and information provided to FAnGR by the Welsh Black Cattle Society. Welsh Blacks are therefore currently ineligible for inclusion under the Glastir scheme.

This is part of the Commission's approach to supporting effective and positive working relationships across the Assembly workforce. The cost is in the order of £30k per annum, including the national insurance and pension contributions we pay as employer.

Other Assembly employees are allowed facility time to undertake trade union related activities, as recognised under our Partnership Framework with the trade unions.

The device is used for testing purposes, but its main function is as part of a lightweight autocue system which is used when filming Assembly Members and staff for Assembly information videos, which are distributed to the public via Senedd.tv and other web channels such as You Tube.
