

## NATIONAL ASSEMBLY FOR WALES

### MEMORANDUM OF CORRECTIONS PURSUANT TO STANDING ORDER 22.13 THE ANIMAL BY-PRODUCTS (IDENTIFICATION) (AMENDMENT) (WALES) REGULATIONS 2002

#### **Background**

These Draft Regulations were laid before the National Assembly for Wales on 14<sup>th</sup> May 2002, considered by the Business Committee on 14<sup>th</sup> May 2002 and by the Legislation Committee on 23<sup>rd</sup> May 2002.

The need for certain drafting changes was identified by the Legal Advisers to the Legislation Committee prior to the Committee's meeting and amendments suggested in consequence. In addition, further drafting changes of a purely technical nature became necessary as a result of suggestions by the Food Standards Agency.

The amendments were reported and agreed by the Legislation Committee in its meeting on 21<sup>st</sup> May 2002, for consideration by the Assembly as follows:-

#### **Amendments**

##### **1. The Explanatory Note**

1.1. In paragraph (a), the third and sixth lines, Welsh text only, omit the words "*storfeydd oer a*" (two references);

1.2. In paragraph (a), the ninth line, Welsh text only, omit the words “*storfa oer neu*”;

1.3. In paragraph (b), the fourth line, Welsh text only, substitute the words “*sy’n dofednod marw adeg*” for the words “*sydd wedi marw ar ol*”.

## 2. The dates made and coming into force

2.1. These shall be 30<sup>th</sup> May and 15<sup>th</sup> July respectively, in both texts.

## 3. The preamble

3.1. In the preamble, 13<sup>th</sup> and 14<sup>th</sup> lines, Welsh text only, insert the words “*yn unol ag adran 48(4) a (4B) o’r Ddeddf honno mae Cynulliad Cenedlaethol Cymru*” after the reference to footnote (c) and before the words “*yn gwneud y Rheoliadau canlynol*”.

## 4. The Regulations

4.1. **Regulation 1** - in the fourth line, both texts, insert the date “*15<sup>th</sup> July 2002*”.

4.2. **Regulation 2(2)(e)** - in the third line of the inserted wording, both texts, substitute “*Regulations*” for “*regulations*” and add a semi-colon at the end of the sentence.

4.3. **Regulation 2(5)** - after Regulation 2(4), Welsh text only, insert a new regulation 2(5) as follows -

*“Ym mharagraff (2)(c) o reoliad 5, mae’r geiriau “cold store, cutting premises,” yn cael eu mewnosos cyn y gair “slaughterhouse”;*

and renumber regulations 2(5) to 2(8) as 2(6) to 2(9) respectively.

**Reasons for the Amendments**

Minor drafting errors and minor technical changes, together with some minor typographical errors.
