## **XML Measures and Bills**

## **Request for information**

Thank you for your request, received on 17 January, in which you noted the following:

I wish to request an XML copy of all Public Measures and Bills:

- as tabled;
- as amended following Stage 2;
- as amended following Stage 3; and
- as passed.

The Assembly's Legislation Data API (<u>http://legislation-data.assembly.wales</u>) was established in November 2017 to provide access to legislation in an open and accessible data format. At present, the site includes XML versions of:

- every Act of the Fourth Assembly;
- every Act of the Fifth Assembly;
- some of the Fifth Assembly's Bills as tabled; and
- every marshalled list of amendments at Stages 2 and 3 tabled during the Fifth Assembly.

Unfortunately, not all of the legislation tabled before the Fourth Assembly (i.e. Measures) and the associated lists of amendments at Stages 2 and 3 are currently available in XML form. By the same token, marshalled lists of amendments tabled for the Fourth Assembly's Bills, and versions of the Fourth Assembly's Bills as tabled, are also unavailable.

Further open data outputs may be available in future, as the open data facility develops, although outputs of this kind could be used to target current rather than historic legislation.
