**The Minister for Culture and Sport (John Griffiths):** The Welsh Government supports the development of grassroots football via Sport Wales. This year, including lottery support, nearly £1m will be invested to support the Welsh Football Trust (WFT) to work with football clubs to help increase participation and assist in coaching programmes within local communities.

In Clwyd, Denbigh Town are being supported by a WFT Development Officer who is involved in developing a new Football in the Community programme and Rhyl Football Club has an extensive community programme, which is also supported by the WFT.

#### Derbyniwyd ateb i'w gyhoeddi ar 24 Ebrill 2013 Answer received for publication on 24 April 2013

**The Minister for Communities and Tackling Poverty (Huw Lewis):** The Welsh Government is committed to tackling homophobic bullying and hate crime. This is reflected in the work being undertaken to take forward our Hate Crime Framework for Action which will be launched for consultation in summer 2013. Written Statement was sent to Assembly Members in March 2013 outlining the priorities and how we will take forward consultation across Wales.

This Framework is being driven by a Task and Finish Group with representatives from Welsh Government policy areas and also with key stakeholders across the statutory and voluntary sector, including the Police, Crown Prosecution Service, Probation Services and Stonewall Cymru. There has been very positive engagement undertaken in collaboration with Stonewall Cymru to date and this has included consultation with community based groups and feedback from Mardi Gras Festivals held throughout Wales. Lesbian, Gay and Bisexual (LGB) people gave a strong representative response to a Welsh Government on-line survey held as an evidence base to the Framework.

The Welsh Government also provides funding to Stonewall Cymru from the Advancing Equality Fund. The organisation is funded to achieve equality for LGB people at home, at school and at work. Their work is tailored to the needs of LGB people across Wales and draws upon a wealth of research from Stonewall across Britain. In October 2011, Welsh Government published new comprehensive guidance on homophobic bullying in schools, as well as four other areas of bullying. Sport Wales is working with Stonewall Cymru to ensure that we create a thriving sporting community within Wales, where Lesbian, Gay and Bisexual people feel safe, welcome and free from discrimination when participating in sport. Sport Wales, in partnership with Stonewall Cymru, launched research findings into 'Understanding Lesbian, Gay and Bisexual Participation in Sport' on 6 December 2012. The report provided a sense of how LGB people living in Wales experience and view sport and, as a result, an LGBT Sport Network has been formed to tackle homophobia in Sport.
