Jonathan Morgan (South Wales Central) ; Rewarding Good Teachers (NDM102VB)

Motions tabled on 7 October 1999

Andrew Davies (Swansea West);

To propose that the Assembly:

- places high priority on policies and initiatives which contribute to the reduction of crime and anti-social behaviour;
- supports the Home Office and the Youth Justice Board in promoting full implementation of the provisions of the Crime and Disorder Act;
- welcomes the proposal to designate the Welsh Assembly as having a role in crime reduction within the locus of that Act, and
- commits itself to the development of vigorous programmes of action designed to prevent offending, especially amongst the young and to take account of the need to "design out crime" while determining its policies and programmes. (NDM104VB)

Motion NDM104VB - Amendments tabled 8 October

1. Peter Black (South Wales West) ;

" To add at the end of the motion ; (R)

- Recognises that social exclusion is a major cause of crime

- Regrets the lack of additional resources provided to support the establishment of Youth Offender Teams and Crime Reduction Partnerships
- Supports the extension of " Home Crime Prevention Survey " schemes throughout Wales
- Supports the introduction of closed circuit television to major crime spots in Wales and its proper monitoring through the current code of guidance, where local people support it and where there is adequate police resource to support its use. "

2. Helen Mary Jones (Llanelli) ;

1. To delete bullet point 2, and replace with ; " expresses its grave reservations about the Child Curfew Orders and calls on the UK Government to amend the legislation, in consultation with the police, civil liberties groups, and other appropriate bodies, in order to ensure that it is compatible with the Human Rights Act 1998. "
2. Insert after bullet point 1 ; The Assembly notes that the National Assembly for Wales is currently subject to the provisions of the Human Rights Act 1998, which incorporates into UK law the European Convention on Human Rights. "
3. In bullet point 3, delete " the Welsh Assembly " and replace it with " the National Assembly for Wales. "
4. In bullet point 4, after " determining its policies and programmes ", add ; " such programmes to include measures designed to combat social exclusion, which is a major factor in creating a culture of crime. "

To propose that this Assembly notes the steps taken by the Assembly Cabinet to win support for a Welsh calf scheme, and registers its deep disappointment that its proposals for the scheme have not been approved by the European Commission, and reaffirms its commitment to helping the Welsh dairy industry build a successful future by addressing the priorities set out in the Action Plan for the dairy sector.
