The National Assembly expresses its concern at the delay in dealing with claims for compensation by former miners and their families in Wales following the High Court ruling on the 23rd January 1998, and calls on the First Minister to make the strongest representations to the UK government to:

- Employ more medical and administrative staff to speed up the processing of claims
- To abolish its clawback of benefit payments from the settled claims immediately, and
- End its challenge to the pension loss element of compensation claims.

The following amendments were selected:

Place a full stop after "January 1998" and insert

'The persistent changes in Ministerial responsibility for this matter has compounded the delay'

before "and calls on"

2. Andrew Davies (Swansea West);
