

Adroddiad Blynyddol Datblygiadau o Arwyddocâd Cenedlaethol - Rhagfyr 2021

Cefndir

1. Mae Datblygiadau o Arwyddocâd Cenedlaethol ("DNS") yn cynnwys prosiectau seilwaith o bwysigrwydd cenedlaethol. Fel sy'n ofynnol gan adran 62D o Ddeddf Cynllunio Gwlad a Thref 1990 ("y Ddeddf Gynllunio"), gwneir ceisiadau cynllunio DAC i Weinidogion Cymru.
2. Mae adran 62L (2) o'r Ddeddf Gynllunio yn ei gwneud yn ofynnol i Weinidogion Cymru benderfynu ar geisiadau cynllunio DAC cyn diwedd y cyfnod penderfynu rhagnodedig, sef 36 wythnos sy'n dechrau ar y dyddiad y derbynnir y cais DAC gan Weinidogion Cymru.
3. Mae adran 62L (5) o'r Ddeddf Gynllunio yn rhoi'r pŵer i Weinidogion Cymru ddyroddi hysbysiad i (a) atal dros dro redeg y cyfnod penderfynu mewn achos penodol am gyfnod a bennir yn yr hysbysiad a (b) terfynu, lleihau neu ymestyn cyfnod atal presennol.
4. Mae adran 62L (8) o'r Ddeddf Gynllunio yn ei gwneud yn ofynnol i Weinidogion Cymru osod gerbron Cynulliad Cenedlaethol Cymru (Senedd Cymru bellach) adroddiad blynyddol ar eu cydymffurfiaeth â'r ddyletswydd a osodir gan adran 62L (2) ac arfer eu swyddogaethau o dan adran 62L (5).
5. Mae'r adroddiad hwn yn cynnwys yr adroddiad blynyddol sy'n ofynnol gan adran 62L (8) o'r Ddeddf Gynllunio.
6. Penderfynodd Gweinidogion Cymru 5 cais cynllunio DAC rhwng mis Rhagfyr 2020 a mis Rhagfyr 2021. Penderfynwyd ar bob cais o fewn y cyfnod penderfynu statudol. Defnyddiwyd pwerau atal dros dro ar gyfer 4 o'r ceisiadau. Ceir manylion yn yr Atodiad amgaeedig.

Developments of National Significance Annual Report - December 2021

Background

1. Developments of National Significance (“DNS”) comprise infrastructure projects of national importance. As required by section 62D of the Town and Country Planning Act 1990 (“the Planning Act”), DNS planning applications are made to the Welsh Ministers.
2. Section 62L (2) of the Planning Act requires the Welsh Ministers to determine DNS planning applications before the end of the prescribed determination period, which is 36 weeks beginning with the date on which the DNS application is accepted by the Welsh Ministers.
3. Section 62L (5) of the Planning Act provides the Welsh Ministers with the power to issue a notice to (a) suspend the running of the determination period in a particular case for a period specified in the notice and (b) terminate, reduce or extend an existing period of suspension.
4. Section 62L (8) of the Planning Act requires the Welsh Ministers to lay before the National Assembly for Wales (now Senedd Cymru) an annual report on their compliance with the duty imposed by section 62L (2) and the exercise of their functions under section 62L (5).
5. This report comprises the annual report required by section 62L (8) of the Planning Act.
6. The Welsh Ministers determined 5 DNS planning applications between December 2020 and December 2021. All applications were decided within the statutory determination period. Suspension powers were used for 4 of the applications. Details are provided in the attached Annex.
