Mae adran 173 o Ddeddf Llywodraeth Leol 1972 yn gwneud darpariaeth i aelod o gyngor plwyf yn Lloegr neu o gyngor cymuned yng Nghymru sy'n gynghorydd gael taliad yn lwfans presenoldeb nad yw'n fwy na'r swm a ragnodir drwy gyfrwng rheoliadau ac i aelod o gyngor o'r fath nad oes ganddo hawl i gael taliad o'r fath gael taliad yn lwfans colled ariannol nad yw'n fwy na'r swm a ragnodir drwy gyfrwng rheoliadau.		Section 173 of the Local Government Act 1972 makes provision for a member of, in England, a parish or, in Wales, a community council who is a councillor to receive a payment by way of attendance allowance which does not exceed the amount prescribed by regulations and for a member of such a council who is not entitled to receive such a payment to receive a payment by way of financial loss allowance which does not exceed the amount prescribed by regulations.

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 173(1), (2) a (4) a 175(1A) o Ddeddf Llywodraeth Leol 1972(a) a freiniwyd bellach yng Nghynulliad Cenedlaethol Cymru i'r graddau y maent yn arferadwy yng Nghymru(b).

The National Assembly for Wales makes the following Regulations in exercise of the powers given to the Secretary of State by sections 173 (1), (2) and (4) and 175(1A) of the Local Government Act 1972(a) which are now vested in the National Assembly for Wales so far as exercisable in Wales(b).

Enwi, cychwyn a dehongli

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Awdurdodau Lleol (Lwfansau Aelodau) (Diwygio) (Cymru) 2001 a deuant i rym ar 1 Awst 2001.

Name, commencement and application

1.-(1) The name of these Regulations is the Local Authorities (Members' Allowances) (Amendment) (Wales) Regulations 2001 and they shall come into force on 1st August 2001.

(2) These Regulations apply to Wales only.

Diwygiadau

2.-(1) Diwygir Rheoliadau Awdurdodau Lleol (Lwfansau Aelodau) 1991(c) yn unol â'r paragraffau canlynol.

yn lle "£30.39" rhowch "£31.39".

(3) Yn Rheoliad 18,

(a) ym mharagraff (1), yn lle "£30.39" rhowch "£31.39";

(b) ym mharagraff (2),

(i) yn is-baragraff (a) yn lle "£27.65" rhowch "£28.81"; a

(ii) yn is-baragraffau (b) ac (c), yn lle "£55.31" rhowch "£57.63".

Amendments

2.- (1) The Local Authorities (Members' Allowances) Regulations 1991(c) are amended in accordance with the following paragraphs.

(2) In Regulation 17, in paragraph (2),

for "£30.39 substitute "£31.39".

(3) In Regulation 18,

a. in paragraph (1), for "£30.39" substitute "£31.39";

b. in paragraph (2),

(i) in sub-paragraph (a), for "£27.65" substitute "£28.81"; and

(ii) in sub-paragraphs (b) and (c), for "£55.31" substitute "£57.63".

3. Mae Rheoliadau Awdurdodau Lleol (Lwfansau Aelodau) (Diwygio) 2000(ch) wedi'u diddymu mewn perthynas â Chymru.

3. The Local Authorities (Members' Allowances) (Amendment) Regulations 2000(d) are revoked in relation to Wales.
