Antoinette Sandbach (North Wales): Further to the information stated on pages 34-35 of the 'Working Smarter' report, will the Minister confirm whether the 3 day movement reporting rule applies to calendar or business days in Wales. (WAQ60288)

The Deputy Minister for Agriculture, Food, Fisheries and European Programmes (Alun Davies): The 3 day movement reporting rule for bovines applies to calendar days not business days as set out in Schedule 4 of the Cattle Identification (Wales) Regulations 2007. The British Cattle Movement Service (BCMS) operate a 24 hour service 7 days a week for Great Britain. Cattle keepers can report movements to the Cattle Tracing System (CTS) via the online or automated telephone services. Movement cards can be posted for cattle born before 1 August 2011. The independent Working Smarter report highlights the confusion surrounding the understanding of this rule and I have accepted recommendation 34, which requests inter-government debate to determine the extent of rule breaches and the underlying causes of breach.
