Approval will be granted for our programme once the Commission has endorsed the UK framework scheme. We expect to be able to publish more information later in the autumn.

**The Minister for Finance and Leader of the House (Jane Hutt):** The total number of products used (Welsh and non-Welsh) by Compass Group in conjunction with the Welsh Government's catering contract is approximately 748 – of which 315 items are produced or grown in Wales (42%).

Of the 748 products, not all can be produced or grown in Wales - e.g. bananas; pineapples; coffee; tea. The total number of products that can be produced or grown in Wales and used as part of the catering contract is approximately 375 - of which 315 items are currently purchased (84%).

**Jane Hutt:** The value of the Welsh Government's catering contract for 2011-12 was £332,587. For the same period, the value in cash terms of produce used from Welsh manufacturers and suppliers was £137,544, which equates to approximately 41%.

**Jane Hutt:** The total number of suppliers used by the Welsh Government's catering contractor Compass Group is 11. The company uses one main distributor for Welsh produce (Castell Howell) and one distributor for non-Welsh produce (Brakes). These distributors are classed as 2 of the 11 suppliers and they in turn, purchase from a wide range of suppliers.

The distributor for Welsh produce, Castell Howell, sources from approximately 77 Welsh-based suppliers and producers.

**The Minister for Health and Social Services (Lesley Griffiths):** Cardiff and Vale NHS Trust have held a number of meetings, over several months, consulting various stakeholders on proposed changes to the management of the Sickle Cell and Thalassaemia service to ensure its sustainability for the future. A new service model for the diagnosis and treatment of Sickle Cell and Thalassaemia will commence following the appointment of the genetic counsellor post, in early 2013. In the meantime, the Sickle Cell and Thalassaemia service has moved to the newly constructed Butetown Health Centre and is now offering 7 clinic sessions per week.

**Lesley Griffiths:** The Dementia Services Developmental Centre (DSDC) has been funded to review, develop and deliver training to a wide range of individuals and organisations, including staff in care homes, primary care and hospital settings, and families and carers. Similarly, the Wales Mental Health in Primary Network is supported to liaise with primary care professionals, including GPs, nurses and practice managers, to increase dementia awareness. The Network will be working to increase understanding of the importance of early diagnosis, timely interventions, the dementia register and memory clinic provision.

The Welsh Government, through the Care Council is undertaking a range of work to support the social care workforce working with people with dementia, including development of competence-based qualifications. There are also a number of Qualification and Credit Framework units within the health and social care diplomas that support the learning and development of social care workers working with people with dementia.

Our forthcoming mental health strategy for Wales, 'Together for Mental Health', will reiterate the objectives of the 'Dementia Vision' and outline action to be taken in future years.

**Lesley Griffiths:** The Deputy Minister for Children and Social Services made a Written Statement on this issue on 12 July. We are committed to building a new, fair and affordable system of paying for social care in Wales. The recommendations in the (Dilnot) Report of the Commission on Funding of Care and Support are for England alone to consider but are helpful in offering potential solutions for Wales. I am pleased some of them are consistent with our existing policies, such as our £50 weekly maximum charge for non-residential care services. Full implementation of the Dilnot proposals, however, would cost us around £100 million per annum and rising with demographic change. A transfer of new money to Wales would therefore be needed.

The UK Government agrees in principle to Dilnot's proposals though details of their approach to the policy and legislative changes that would be required will follow the 2013 Spending Review. The Deputy Minister for Children and Social Services has expressed disappointment with this delay, and will seek a meeting with the new Minister for Care Services, Norman Lamb MP. Officials have consulted with key stakeholders in Wales to ascertain what kind of system would command broad public support here, and whether such reforms should be built on the Dilnot proposals. Those findings will be published soon. We will also wish to establish cross-party dialogue about how we tackle this important issue.
