What is the National Assembly for Wales? The National Assembly for Wales is made up of 60 Assembly Members from across Wales. They are elected by the people of Wales to represent them and their communities, make laws for Wales and to ensure the Welsh Government is doing its job properly.

How to present an idea for a new law or a campaign to Assembly Members

Aim:

Find out how to present an idea for a new Law for Wales or a campaign to Assembly Members

Purpose:

- -To raise awareness of the Assembly's petitions system.
- -To provide information about how to submit a petition to the National Assembly for Wales.
- -To look in detail at some of the petitions which have been received by the Assembly.

Skills:

- -Communication pair / group / class work.
- -Oracy creating scrutiny questions.
- -Presenting an idea in front of an audience.

Activities:

- -Discuss a petition in a small group. Would they support that petition?
- -Discuss the scrutiny questions they would ask the petitioner(s) if they were giving evidence to the Committee.
- -Present the petition to the whole class and share their opinions about that petition.

Resources:

- -Petitions video.
- -Resource 08: Petitions cards (laminated) one for each group.
- -Teachers' notes giving further information about the petitions.
- -Teachers' notes giving tips for presenting a successful petition.

Further work:

-The pupils could think of petitions they would like to present to the Assembly.

How to present a petition as a campaign or an idea for a new law for Wales to Assembly Members?

01. Watch a video on the Assembly's website http://www.assemblywales.org/gethome/e-petitions.htm

02. Discuss petitions which have been presented to the Assembly.

Divide the class into 5 groups. Each group will be given a card which notes the details of a petition which has been presented to the Assembly. A choice of 9 different petitions is available. Further information about these petitions, together with information about other petitions which have been presented can be seen on the Assembly's website.

03. Whilst discussing the petition which is on their card, the pupils need to discuss the following questions:

-Would you support this petition? Why?

-If you were an Assembly Member, which questions would you put to the petitioners when they came in to give evidence to the Committee?

The pupils will need to prepare to present the petition to the rest of the class and to give their own opinions about that petition.

04. Every group will present the petition they have been discussing to the rest of the class, giving their own opinion about the petition.

05. After the presentations by the 5 groups, the whole class will vote for the best petition of the 5 presented.

Tips for submitting a successful petition

Read the guidelines on the Assembly's website, and then make sure that your petition will be admissible (i.e. within the 20 Subject areas).

You are welcome to contact the Petitions Committee **before** submitting your petition: **petition@wales.gov.uk** or 029 2089 8998.

Keep the wording of your petition short (one or two sentences). Further information can be submitted separately. Your petition should clearly state the action you are calling on the National Assembly to take.

Your petition wording should start with "We call upon the National Assembly for Wales to" or "We call upon the National Assembly for Wales to urge the Welsh Government to ..."

There will need to be a lead petitioner and you will only need to collect a minimum of 10 signatures before you can submit your petition.

Alternatively, a petition can be submitted in the name of a group or organisation (this could be a school council). In this case you will not need to collect signatures.

You can submit your petition by email to **petition@wales.gov.uk**.

You can also send the petition by post to: The Petitions Committee The National Assembly for Wales Cardiff Bay CF99 1NA

You may also like to present your petition in person; this can often lead to increased publicity for your cause.

After you submit a petition, one of the petitions team will be in touch with you within a few days. They will ask for further information such as why you want to start the petition and any action you have already taken.
