The Minister for Health and Social Services (Lesley Griffiths): An All Wales Sleep Apnoea Working Group, comprising of respiratory consultants delivering sleep apnoea services in NHS Wales, produced a proposal for minimum clinical standards for sleep apnoea in Wales.

The recommendations of the group were accepted and the advisory document 'Sleep Disordered Breathing Services in Wales' was issued to Chief Executives of all Health Boards in Wales in February 2011, to assist them in planning for improved sleep services.

Local authorities are subject to a range of statutory requirements governing the management of resources and the provision of, and access to, information.
