Purpose

The amendment moves the basis for the pupil element of school funding from a one year basis to a rolling average of 3 years. This will still involve the same sum of money funding the same number of schools, but will provide greater consistency of funding for all schools in Wales, though particularly the smaller schools which can be hard hit by relatively small numbers of pupils departing having a proportionately big impact on that schools funding.

Cost

There is no additional cost, though the greater security and consistency of funding may lead to fewer staff being made redundant or being employed on short term contracts and thus save money for schools and LEAs from redundancy pay and/or re-appointment costs.
