These will be able to take account of the results of the 2011 Census of population.

**John Griffiths:** John Griffiths: Users of local authority population projections (including local authorities and the WLGA) were consulted in January 2011 about the future timetable for local authority population projections in Wales. Feedback received indicated that users were content with the proposal that the next update to the local authority population projections for Wales would be 2011-based projections which will be available in 2013. These will be able to take account of the results of the 2011 Census of population. Technical aspects of methodology for population projections are developed in close cooperation with local authorities and key users in Wales – through the Welsh Sub-national Population Projections Working Group (WASPP). WLGA and other users will be kept informed of developments once work is underway to prepare the next set of projections.

Such projections form the starting point when Local Development Plans are being prepared. The Welsh Government's guidance indicates that it is acceptable to deviate from the projections, provided there is a justified reason for doing so.

**The Minister for Finance and Leader of the House (Jane Hutt):** My officials are liaising with the Office for National Statistics through the UK Population Committee and UK Census Committee regarding the availability of population data for each Welsh Local authority following the 2011 Census. First census results are expected to be published by the Office for National Statistics in July 2012 and these are expected to include data for local authorities in Wales and England.

**The Minister for Local Government and Communities (Carl Sargeant):** The Welsh Government has funded Network Rail to produce a feasibility report to identify costed options for track and signalling improvements that are required to provide a train service from Ebbw Vale to both Cardiff and Newport. This is expected shortly.

I am currently considering my transport priorities and will consider this scheme further once Network Rail's report has been received and reviewed.
