Andrew RT Davies (South Wales Central): Will the Minister outline how much money has been spent by the Welsh Assembly Government in the last 5 years on the protection of Dara and Defence Support Group jobs located in St Athan. (WAQ57016)

Answer issued on 08 February 2011

Since acquisition of the site in 2003 and up to 31 October 2010, £13.329 million has been spent on airfield operations and maintenance costs with the specific aim of supporting users of the aerodrome and retaining vital skills in Wales. This expenditure represents sums spent by the Assembly Government and the former Welsh Development Agency.

The above figure includes a net cost of £5.254 million incurred in the reconstruction of the runway which has a design life of fifteen years.

Andrew RT Davies (South Wales Central): Will the Minister provide the figure for how many Dara and Defence Support Group jobs (in total) have been safeguarded through Welsh Assembly Government investment at St Athan. (WAQ57017)

From 2009 and until the end of 2012, approximately 339 Defence Support Group jobs in total have been protected through the contribution the Assembly Government is making towards the annual operational costs of the airfield and the reconstruction of the runway at St Athan.

Brynle Williams (North Wales): Will the Minister provide an update on the Welsh Assembly Government's work to prepare for the change from historic to area-based single farm payments. (WAQ57024)

Answer issued on 08 February 2011

The Welsh Assembly Government has undertaken extensive research and impact assessments to prepare for this change. Through scenario planning we have been able to estimate the numbers of farmers that would receive higher and lower payments and the extent of those gains and losses in relation to several different variables including a standard all Wales average payment and a differential payment between LFA and non LFA. We have also looked at the impact on the different sectors. The LFA beef and sheep sector tends to fair rather better irrespective of scenario while the dairy sector fairs less well although there are winners and losers in every sector for all scenarios. It is most unlikely that the historic basis to Single Payment will be tenable after 2013 and I will be pressing for a lengthy transitional period to area based payments to minimise the impact of the redistribution.

Brynle Williams (North Wales): Will the Minister provide an update on her discussions with Defra concerning the future funding of animal health budgets. (WAQ57026)

Animal health and welfare powers are already largely devolved to Wales. DEFRA has proposed to devolve a proportion of the animal health and welfare budgets, currently held on a GB basis, by April 2011. Negotiations have been complex and have covered issues such as; the financial split between Administrations; the conditions to be imposed on the settlement; and future governance arrangements between Administrations. These discussions are nearing a conclusion. I then expect to receive a formal offer of funding. Once in receipt of the offer, I will be in a position to make a final determination on whether the settlement and any conditions attached to the offer are acceptable to Wales.

Andrew RT Davies (South Wales Central): Will the Minister provide figures for how much grant aid/financial support WAG have provided to RCMA Social Enterprise Ltd in each of the last four years. (WAQ57020)

I can advise that Riverside Community Market Association Social Enterprise Ltd (RCMA) received £12,000 for a feasibility study into the viability of establishing a Community Garden in 2007. This has since been established and RCMA won a gold award in the Wales the True Taste Awards 2010 for a Local Sourcing Initiative - for their Community Enterprise and Riverside Market Garden.

RCMA has also received funding (in 2010) to put a Processing and Marketing Grant application together via our Food Business Development Advisors (FBDA) - at a cost of £2,500.
