**The Minister for Health and Social Services (Mark Drakeford):** I am concerned about Ambulance Service performance and that is one of the reasons we commissioned a Review of Welsh Ambulance Services. I am considering the recommendations from the McClelland Review and will use the findings and the debate on 7th May to implement changes to support the delivery of high quality ambulance services in Wales.

Between 1 October 2012 and 31 March 2013, 54.9% of emergency responses to Category A (immediately life-threatening) calls arrived at the scene within 8 minutes in Mid and West Wales.
