**The Minister for Local Government and Communities (Carl Sargeant):** A study has been undertaken focusing on the transport issues on the trunk road corridor between Deeside and Northop, including the A494 Aston Hill, and identifies options for addressing these issues. The A55/A494 WelTAG Stage 1 Appraisal study report was published on Monday 12 November. We will now move forward to the next stage to examine the options in more detail including full consultation with the local community and other stakeholders.
