Un o'r ymrwymiadau yn y Rhaglen Lywodraethu yw ymrwymiad i "gynyddu'r cyfraddau imiwneiddio plant er mwyn dileu'r problemau iechyd a achosir gan y frech goch, clwy'r pennau a rwbela". Caiff hyn ei fesur yn ôl nifer y plant sy'n ddwyflwydd oed a gafodd eu brechu yn erbyn MMR. Y targed yw sicrhau bod 95% o blant yn cael dau ddos o'r brechlyn.

Mae nifer y plant sy'n cael eu brechu yng Nghymru wedi bod yn cynyddu'n araf ac yn gyson ers y canran isel o 77% a gofnodwyd yn 2003. Erbyn hyn mae nifer y plant dwyflwydd oed sy'n cael y dos cyntaf o'r brechlyn MMR yn 93.3%, a nifer y plant pum mlwydd oed sy'n cael y dos cyntaf yn 95.2%. The Minister for Health and Social Services (Lesley Griffiths): At 19 March, 42 cases of measles have been clinically diagnosed in the recent outbreak in the Porthmadog area. The majority of cases have either had no MMR vaccination or only one dose. The outbreak is being managed by Betsi Cadwaladr Health Board and Public Health Wales.

The Programme for Government includes a commitment to "increase immunisation among children to eradicate the health problems caused by measles, mumps and rubella". This will be measured by the number of children aged 2 years who have been immunised against MMR. The target is 95% of children to receive two doses of vaccine.

MMR uptake in Wales has been increasing slowly and steadily since the low point of 77% in 2003. Uptake of the first dose is now 93.3% at two years of age and 95.2% at five years of age. Uptake of the second dose at five years has also increased to 87.6%. (Public Health Wales COVER report Quarter 4, 2011).

As part of this strategy, we are committed to working with the NHS to ensure the mental health needs of Gypsies and Travellers are identified and addressed in local healthcare strategies and policies, including Health, Social Care and Well-being Strategies and associated needs assessments, Children and Young Peoples Plans, equality schemes, and engagement and consultation mechanisms. In particular, the 'Health of Homeless and Specific Vulnerable Groups Standards' issued in 2009, acknowledge the Travelling community as a vulnerable group at risk of mental ill-health. The Standards address the problems which Gypsies and Travellers face in accessing primary healthcare, and set expectations on Health Boards (as lead organisations) and local authorities (as supporting partners) to ensure Gypsies and Travellers can readily access primary care services and their health needs addressed. The forthcoming Mental Health Strategy for Wales 'Together for Mental Health', aims to strengthen mental health provision for all vulnerable groups by ensuring all partner agencies meet their equality duties and removing discriminatory practices in relation to individuals with 'protected characteristics'.

The Assessment evidenced that there will be some adverse impact on people with protected characteristics within the CTCFI areas when the scheme closes. However, these groups will not be more disadvantaged than people with the same characteristics living elsewhere in Wales.

**Carl Sargeant:** Between 2004 and 2011 the Welsh Government provided over £5.5m to the FRAs to deliver over 375,000 Home Fire Safety Checks and provide free smoke alarms and other fire safety preventative equipment.

Our new Fire and Rescue National Framework for Wales, which will be introduced on 20 April 2012, sets out the priorities and actions for Fire and Rescue Authorities (FRAs) in Wales from 2012 onwards. The FRAs have responsibility to continue to work collaboratively with the Police, Local Authorities, Community Safety Partnerships and other relevant key stakeholders in delivering their preventative and protection initiatives including communicating the importance of smoke alarms in homes.
