- b) Membership of the Group is comprised of Welsh Government, Natural Resources Wales, Forestry Commission, Forest Research, the private sector (ConFor, Wales Forest Business Partnership and a private landowner) and the voluntary sector (Wales Environment Link, including a representative of the Woodland Trust);
