## **Background**

These Draft Regulations were laid before the National Assembly for Wales on 29<sup>th</sup> June 2000, considered by the Business Committee on 28<sup>th</sup> June 2000 and by the Legislation Committee on 4<sup>th</sup> July 2000.

Typographical and drafting errors were identified by the Legal Advisers to the Legislation Committee prior to the Committee's meeting and amendments were suggested in consequence. The amendments set out below were reported to the Legislation Committee at its meeting on the 4<sup>th</sup> July and agreed by it for consideration by the Assembly:-

## **Amendments**

### **Regulation 3**

#### **Amendment 1**

In the heading substitute "to for "of".

#### **Reason for the amendment**

Grammatical change.

### **Regulation 3(4)**

#### **Amendment 1**

In the opening line replace the second "Regulation" with "paragraph" and delete "8".

#### **Reason for the amendment**

To ensure that text is in line with normal practice.

**Amendment 3**
