## MEMORANDUM OF CORRECTIONS PURSUANT TO STANDING ORDER 22.13

### The National Health Service (Charges for Drugs and Appliances) (Wales) Regulations 2001

#### Background

These Regulations were laid before the National Assembly for Wales on 15<sup>th</sup> March 2001, were considered by the Business Committee on 13<sup>th</sup> March 2001 and by the Legislation Committee on 20<sup>th</sup> March 2001.

The draft regulations were submitted to the Legal Advisers prior to the Committee and no points were identified as matters in respect of which the Committee needed to pay special attention.

When the order was formally considered by the Legislation Committee however, it was found to contain minor drafting errors.

The amendments were reported and agreed by the Legislation Committee in its meeting on the 20<sup>th</sup> March 2001 for consideration by the Assembly as follows:-

## **1. Rheoliad 2**

## **4. Rheoliad 12**
