Where we do need to use agencies for TS - Executive Band, we use the National Procurement Service (NPS) Wales Framework, that include agencies not necessarily based in Wales. However, this has not been utilised in the last financial year.

Where we have failed to appoint from the NPS framework or have required assistance with the recruitment of specialist posts, such as at Director Level or Public Appointments, we have consulted appropriate recruitment agencies.
