- () It shall be the duty of the local authority to provide the officer designated under subsection [] with such staff, accommodation and other resources as are in the officer's opinion, sufficient to allow the duties under subsection [] (a) to (c) to be performed.
- () The officer designated under subsection [] must have significant and suitable experience in social work and hold a suitable recognised qualification.
- () The local authority must take account of the report referred to in subsection [] and must ensure that any action required by the report is undertaken in compliance with any specified timescale.'
