'Notes with concern that only one third of employment growth is occurring in Objective One areas, despite having two-thirds of the Welsh population, and calls on the Labour Assembly Government to establish regional economic targets throughout Wales to ensure direct economic opportunities to areas of greatest need.'

Notes with concern that there is a growing divide in Welsh GVA per head with the rest of the UK from 85.3% in 1978 to 78.8% in 2001

Calls on the Welsh Assembly Government to reaffirm that "Success would mean Welsh GDP per person rising from 80 per cent to 90 per cent of the UK average over the next decade – with the ultimate aim of achieving parity" as stated in 'A Winning Wales'.

Notes the First Minister and acting Economic Development Minister's comments in the Chamber on December 13 2001 that stated "Many things must go right for us to achieve that target of 90 per cent of UK average GDP per capita.
