Dear Andrew,

Thank you for your Written Question asking me what discussions the Welsh Government has had with the British Medical Association regarding a return to face-to-face appointments in GP surgeries?

The Welsh Government has regular engagement with the BMA including GP Forum bimonthly meeting with both the BMA and RCGP Wales where the way practices operate is often discussed including face to face consultations. From these discussions, during the summer, a joint letter was issued to the GP profession from Welsh Government, GPC Wales, RCGP Wales and the health boards expressing the importance of patients being able to contact the practice and how there is an expectation for practices to see patients both face-to-face and via remote consultations.

GP's, as independent contractors, are ultimately responsible for the specific appointment system used by their practice, but are required to provide a system that ensures the safety of staff, patients and the clinician. For some people, where clinically appropriate, face to face consultations are the best option but for others it may be quicker, easier and just as effective to do so by phone or video.

On 1 December I announced the agreed changes to the GMS contract for 2021-22, which includes new requirements around access that will mean patient need is managed more effectively and in a more forward looking and planned way. Crucially, these changes mean that the release of all appointments at 8am, or other narrow window of time, is no longer acceptable. These changes will support the new blended model of access that includes face-to-face and remote consultations, in line with clinical and patient need.

In addition, Our Help Us Help You campaign has produced materials in collaboration with the BMA and other partners to help inform the public of what they can expect from their GP practice. We will continue to build on that campaign, where needed, in light of the recent contract changes.
