- 4. If any Senedd Members are exempt, what are the grounds for exemption?

Please find our response to your request below.

1. How many Senedd Members own second homes in Wales?

Members of the Senedd must register the land and property they own on their **Register of Members' Interests (senedd.wales)**, under 8. Category 8: Land and property.

- 5. All claims are published on our allowances system **three months in arrears** and will show in the financial year to which the cost relates. If you are unable to follow these instructions, please let me know.

As this information is already available, your request is subject to section 21 of the FOIA which exempts information that is already reasonably accessible by other means.

We do not hold recorded information in relation to second homes owned or rented by Members in cases where no claim is made under the Determination.

3. Are any Senedd Members exempt from paying council tax for their second homes? We hold no recorded information relating to this part of your request.
