Other Business

Consideration of the Business Rate Supplements Bill: Delegated Powers memorandum

The Members noted the Delegated Powers Memorandum for the Business Rates Supplement Bill sent to the Committee by the Welsh Assembly Government. The Members expressed their regret that they had received the Memorandum after the meeting attended by the Minister for Social Justice and Local Government, Dr Brian Gibbons AM, and the Counsel General and Leader of the House, Carwyn Jones AM, which made it impossible to question them orally about any issues contained in the document. The Members requested that all such memoranda should be available for the Committee in time for their consideration of Bills. In respect of the Business Rate Supplements Bill the Committee agreed that the Minister be asked to clarify the Welsh Assembly Government's position in respect of the rateable value threshold for non-domestic properties, which would not generate any liability to pay the supplement, having regard to the statement that in England the rateable value would be £50,000.

These Regulations replace Schedule 1 to the Products of Animal Origin (Third Country Imports) (Wales) Regulations 2007.

Under Standing Order 15.2 the Assembly is invited to pay special attention to the following instrument.

There appear to be inconsistencies between the meaning of the English and Welsh texts (SO 15.2 (vii))

In the English text of Schedule 1, Part 10 Fishery Products, paragraph 7 Health Certification refers to Regulation (EC) No 854/2004 of the European Parliament and of the Council.

However, in the Welsh text a reference is made to Regulation (EC) No 854/2005 which is inaccurate and irrelevant to these Regulations.
