### **Minority Party Debate - Plaid Cymru**

*NDM833* - The National Assembly expresses its deepest concern at the continuing delay in dealing with claims for compensation by former miners and their families in Wales following the High Court ruling on the 23<sup>rd</sup> January 1998; deplores the allocation to Wales under the Coalfield Regeneration Fund which is far smaller than the historic contribution of Wales to the coal industry of the UK; and calls on the First Minister to make the strongest representations to the UK government about these injustices as a matter of urgency.

### The following amendments had been tabled:

## Amendment 1 - Andrew Davies (Swansea West);

Delete all wording after "The National Assembly" and replace with:

"recognises the concerns about the delays in dealing with claims for compensation by former miners and their families in Wales, but acknowledges that since the establishment of the Welsh Coal Claims Monitoring Group considerable and accelerated progress has been made and that almost £100m has been paid to former Welsh miners and their families, and looks forward to a speedy resolution of this matter."

# Amendment 2 - William Graham (South Wales East);

Delete the semi-colon after 1998 and insert:

". It recognises that the persistent changes made by the UK Government of the Ministerial responsibility for this matter compounded the delay. It further"
