Thank you for your request received on 26 June. I will answer each part of your request in turn below.

### 1. Do you currently participate in the UK Government's "Cycle to work Scheme"?

The Assembly has offered a cycle to work scheme for staff, Assembly Members and Assembly Member Support Staff since March 2009.

## 2. If so, how many individuals have benefitted from the scheme to date?

To date, a total of 31 individuals have taken the opportunity to obtain a bike through the scheme.

# 3. What procedures do you currently have to monitor the take-up and implementation of this scheme?

The scheme is implemented and managed inhouse in accordance with the guidelines (see link below) laid out by the Department of Transport and HM Revenue and Customs. All applications are processed through an official Cycle to Work administrator 'On Your Bike' who undertake the necessary actions to contact suppliers and process applications within the official guidelines laid out. Any revisions to the scheme are considered and implemented in accordance with the published HMRC guidance. All registered applications are logged and monitoring of existing and new applications is carried out in accordance with payment schedules.
