# SUMMARY OF THE WORK OF THE LEGISLATION COMMITTEE 2003-2004

#### PREFACE BY THE CHAIR OF THE LEGISLATION COMMITTEE

Presenting the First Annual Report of the Legislation Committee of the National Assembly for Wales (Second Assembly) gives me the opportunity to emphasise that the scrutiny undertaken by the Legislation Committee is vital to the proper functioning of this Assembly. It is very important that the Legislation Committee serves the Assembly well in ensuring that all the legislation that is produced here is compliant with requirements of the Standing Orders and the Government of Wales Act. Legislation Committee has a busy role considering legislation in a way that cannot possibly be done in Plenary.

In May 2003, the elections to the Second Assembly took place and the present Committee was elected shortly after that. This Committee has continued and developed the work undertaken by the Committee during the First Assembly. The Committee consists of ten Members, four of whom (including myself) were on the previous Committee. For the other six Members the work of this Committee has been a new experience. I would like to take this opportunity to thank all my fellow Committee Members for their commitment to the Committee's work, their dedication and enthusiasm.

The Assembly Review of Procedure recommended that the Legislation Committee should lay its annual report before the Assembly. Although the current report is entitled "Annual", due to the election, it covers a period longer than one year (May 2003 - August 2004). This Report is laid before the Assembly together with a supplement - the Third Annual Report of the Legislation Committee (First Assembly).

The Committee will continue its efforts to scrutinise thoroughly the subordinate legislation issued by the National Assembly, making it as precise, modern and comprehensible as possible, so that the people of Wales could use it with confidence. We shall do our best to maintain and develop further the high

standards required of the Committee by the Standing Orders. I am certain that the Committee will continue to fulfil its role in the coming year.

Finally, I would like to record my appreciation, and that of the Committee, for the valuable support that we receive from the Legal Advisers to the Committee and the Committee officials. In particular I would like to thank John Turnbull who was Legal Adviser to the Committee throughout the First Assembly and on until December 2003. He helped to steer the Committee through the treacherous waters of the scrutiny of bilingual legislation for the first time in the United Kingdom.

#### INTRODUCTION:

The role of the Legislation Committee is to scrutinise relevant Welsh subordinate legislation to ensure that it is within the enabling powers and is properly drafted. Its statutory basis is set out in sections 58 and 59 of the Government of Wales Act 1998 and its functions are detailed in Standing Order 11.

This is the First Annual Report of the work of the Legislation Committee (Second Assembly), covering the period June 2003 - July 2004. During that time, the Committee considered a total of **263** pieces of subordinate legislation.

This annual report provides an overview of the Committee's deliberations on each piece of legislation scrutinised and considers the impact of the Committee's reports. The results are presented in summary tabular form for ease of reference.

The report also covers the wider aspects of the Committee's work including its general interest in the presentation and quality of National Assembly legislation.

#### SECOND ASSEMBLY: FIRST YEAR ANALYSIS

#### **COMMITTEE RESPONSIBILITIES: Standing Order 11.7**

Standing Order 11.7 sets out the grounds on which the Committee is to invite the National Assembly to pay special attention to legislation:

- doubt as to whether the legislation is within the Assembly's powers
- the legislation appears to make unusual or unexpected use of the powers
- it is excluded from challenge in the courts
- it appears to have unauthorised retrospective effect
- its form or meaning needs further explanation
- its drafting appears to be defective
- it fails to fulfil statutory or other legal requirements
- there appear to be inconsistencies between the English and the Welsh texts.

Before reporting to the Assembly, the Committee is, under Standing Order 11.6, required to notify the relevant Assembly Minister of this intention and invite him or her to give evidence to the Committee.

Where a defect is capable of correction by Memorandum of Corrections, the Committee reports the matter under S.O.11.7, but indicates that its concerns can be addressed by a Memorandum of Corrections to rectify the points identified. During the reporting period it happened on **55** occasions. Of these, there were:


- 3 cases where greater clarity was needed
- 9 cases where greater clarity was needed and drafting errors were present
- **19** cases where drafting errors were present
- 11 cases contained instances of inconsistencies between the English and Welsh texts and defective drafting
- 4 cases contained instances of inconsistencies between the English and Welsh texts
- 1 case contained instances of unusual or unexpected use of Assembly powers, defective drafting, need for further clarification
- 1 case contained defective drafting and typographical mistakes
- **6** cases contained instances of inconsistencies between the English and Welsh texts, defective drafting, need for further clarification
- 1 case contained instances of inconsistencies between the English and Welsh texts, need for further clarification

The Committee invited the Assembly to pay special attention to legislation on **18** separate occasions for the following reasons:

- form or meaning needed further explanation 1 case
- drafting appeared to be defective 8 cases

- unusual or unexpected use of Assembly powers (of which in one case LC903 – there were no powers) – 3 cases
- form or meaning needed further explanation, drafting appeared to be defective and there were some typographical errors - 1 cases form or meaning needed further explanation and drafting appeared to be defective - 5 cases

- **Series 4** form or meaning needed further explanation, drafting appeared to be defective and there were some typographical errors **1** cases

#### **Observations**

Besides reporting formally under Standing Order 11.7, the Committee's reports to the Assembly have included observations on minor defects.

Having considered the total of **263** statutory instruments, the Committee made suggestions regarding:

- the need for greater clarity on 31 occasions;
- the simplification of drafting to assist the reader on 91 occasions;
- typographical errors on 38 occasions;
- grammatical errors on 7 occasions.

In the previous years the Committee has paid particular attention eliminating the use of gender specific language and during the period only **1** Draft Statutory Instrument was found to contain an instance of gender specific language.

The National Assembly is required to produce bilingual legislation except where this is inappropriate or not reasonably practicable. Of the two hundred and sixty three Statutory Instruments submitted, **250** were drafted bilingually and only **10** of these contained inconsistencies between the English and Welsh texts.


At present out of a total of **263** Statutory Instruments considered by the Committee during the period from June 2003 to July 2004, **258** are available as final printed versions. Of these, **91** final versions took on board Committee's suggestions; **29** final versions incorporated some of the Committee's suggestions; **29** did not incorporate the Committee's suggestions; the Committee's points were taken into consideration and amendments were intended by way of an amending Statutory Instrument in **1** case. The Committee did not make any comments on the remaining **108** Statutory Instruments.

In many instances the legal advisers to the Committee were able to comment on early drafts of legislation. As a result, a considerable number of drafting and similar points being rectified prior to formal submission of the legislation to the Committee.

#### **Procedures By Which Legislation Is Made**

The National Assembly processes legislation in four different ways: by Standard Procedure, Executive Procedure, Accelerated Procedure and Extended Procedure. Of the **263** Orders considered by the Committee during the period from June 2003 to July 2004, **77** cases were processed by Standard Procedure; **67** cases - by Executive Procedure; **115** cases - by Accelerated Procedure and **4** cases - by Extended Procedure.

#### **OPERATIONAL MATTERS**

Despite tight deadlines due to weekly meetings, the operational side of the Committee has run smoothly. As soon as a draft Order has been laid before the Assembly it appears on the next available meeting agenda, together with the report of the legal adviser. The Committee Service aims to provide Members with all papers two working days before the meeting. Following each meeting the Committee Service ensures that the Committee's Reports are laid before the Assembly as soon as possible, often on the same day. The finalised reports and minutes are placed on the internet within two working days of each meeting and the aim is also to send any S.O.11.6 letters from the Chair to the relevant Ministers within this time scale.

In April 2004, the Standing Orders of the National Assembly for Wales were updated and the S.O.11.5 changed to S.O.11.7. Although this change has happened in April 2004, in this report S.O.11.7 is quoted throughout. Similarly, other Standing Orders are also quoted as in the updated version.

#### **OTHER ACTIVITIES**

#### **ELECTION TO THE SECOND ASSEMBLY**

The last meeting of the Legislation Committee before the election to the Second Assembly took place on the 25 March 2003. Accordingly, Mick Bates AM(Chair); Ron Davies AM; Dai Lloyd AM; Jonathan Morgan AM; Owen John Thomas AM; Rosemary Butler AM; Tom Middlehurst AM; Pauline Jarman AM and Huw Lewis AM ceased to be the Members of the Committee on 30 April 2003. In addition to the Members mentioned above, the following AMs were members of the Legislation Committee during the first four years: Lorraine Barrett AM, Nicholas Bourne AM, Christine Chapman AM, Glyn Davies AM, Jocelyn Davies AM, Delyth Evans AM, the late Val Feld AM, Michael German AM, Briam Gibbons AM, Janice Gregory AM, John Griffiths AM, Ann Jones AM, Carwyn Jones AM, Peter Law AM, Val Lloyd AM, John Marek AM, Lynne Neagle AM, Alun Pugh AM, Karen Sinclair AM, and Gwenda Thomas AM.

After the election to the Second Assembly, on 3 June 2003 new Members were elected to the Legislation Committee: Glyn Davies AM (Chair); Eleanor Burnham AM; Rosemary Butler AM; Christine Chapman AM; Jeff Cuthbert AM; Irene James AM; Elin Jones AM; Laura Jones AM; Dai Lloyd AM; Catherine Thomas AM (Note: In January 2004 Catherine Thomas AM resigned from the Committee and Tamsin Dunwoody-Kneafsey AM was elected to replace her). The first meeting of the newly-elected Legislation Committee took place on 10 June 2003.

PRESENTATION BY DR RICHARD CROWE, CHIEF LEGAL TRANSLATOR: 'THE CHALLENGE OF TRANSLATING LEGISLATION'.

On 24 June 2003, the Chief Legal Translator in the Office of the Counsel General, Dr Richard Crowe, attended the Committee meeting and gave a short presentation on the work of the team of four senior legal translators, drawing attention to the difficulties in translating secondary legislation. His presentation was followed by a discussion.

# DISCUSSION WITH MR WINSTON RODDICK QC, THE COUNSEL GENERAL: CO-DRAFTING OF LEGISLATION. ALTERATIONS IN LEGAL ADVICE TO THE LEGISLATION COMMITTEE.

On 1 July 2003, the Counsel General Mr Winston Roddick QC attended the Committee meeting and gave a short presentation on "Co-drafting of Legislation and Changes to the Arrangements for Legal Advice to Be Given to the Legislation Committee". The presentation was followed by a discussion. The following topics were covered:

- The importance of the Legislation Committee to the work of the scope of the Assembly and, consequently, the importance of the Members' understanding of the process of making legislation;
- Possibility of the Members' visit to OCG to have a discussion with the lawyers and observe the legislative process;
- The importance of the provision of a high quality independent advice to the Committee in the light of the planned changes in legal advisers;
- The authoritative role of the Counsel General in giving advice to the Assembly;
- The necessity of the development of co-drafting of legislation in the light of the requirement for the Assembly to produce its legislation bilingually, with both the English and the Welsh texts having an equal legal status.

# POINTS OF ORDER MADE BY THE CHAIR OF THE LEGISLATION COMMITTEE GLYN DAVIES AM IN PLENARY

In plenary on 15 July 2003 the Chair of the Legislation Committee Glyn Davies AM made three points of order:

• The first concerned the duty of the Legislation Committee to invite the Assembly to pay special attention to a proposed Assembly Order or other subordinate legislation 'if its drafting appears to be defective or the instrument fails to fulfil statutory or other legal requirements'. The Chair expressed concern that the Committee could not ensure that the legislation-making process was carried out properly if the issue of the consideration of regulatory appraisals by the Committee was not resolved – without scrutinising the regulatory appraisals the Members could not satisfy themselves that the appraisals had been carried out comprehensively. This point of order was supported by Dai Lloyd AM and Mick Bates AM. The Presiding Officer expressed his gratitude to the

Members who had supported this point of order. He reminded the Members that the Assembly Review of Procedure recommended that the Legislation Committee should report 'to plenary if it believes that any statutory requirements, including procedural requirements in standing orders, have not been complied with.' He pointed out that the matter was still before the Business Committee which had sought further legal advice. (Note: Later on in the year the Business Committee decided that it would consider the Regulatory Appraisals itself. When the issue was raised again at the meeting of the Legislation Committee in June 2004, the Legal Adviser explained that the decision regarding the consideration of the Regulatory Appraisals by the Business Committee was made on the basis of the advice it received from the former Counsel General and former Legal Adviser to the Presiding Office. It was decided that the Legal Adviser would prepare a paper on this issue and the Committee would reexamine the matter after the summer recess early in October 2004);

- The second point of order related to the fact that, on a number of occasions, the motions on the plenary agenda did not reflect the fact that the Legislation Committee had drawn the special attention of the Assembly to S.O.11.7 matters in relation to draft Statutory Instruments (whilst correctly stating that those matters could be corrected by a Memorandum of Corrections). The Presiding Officer promised to investigate the issue. (Note: the issue has since been resolved. Motions before Plenary now contain references to the reports of the Legislation Committee and state whether matters referred to therein are capable of correction by means of Memoranda of Corrections, and if so such Memoranda are also laid before Plenary).
- The third point of order concerned the position on legal advice to the Committee and independent legal advice to Members: during his visit to the Committee the Counsel General expressed an opinion that all persons offering legal advice to Members or to the Presiding Officer were answerable to him. The Chair of the Legislation Committee expressed his concern that the Committee, the Presiding Office and all Members should have recourse to independent legal advice. The Presiding Officer stated that he would be happy to be involved in furthering the discussion of this matter by reflecting upon the events of the first four and a half years of the National Assembly. (Note: The system of the legal advice to the Legislation Committee was changed in January 2004)

#### CHANGE OF LEGAL ADVISERS TO THE COMMITTEE

In January 2004, the new Legal Adviser, Gwyn Griffiths, was introduced to the Committee. New Assistant Legal Adviser, Joanest Jackson, joined him later in the year. Unlike their predecessors, they are based in the Assembly Building and form part of the Legal Division of the Assembly Parliamentary Service. The Members expressed the Committee's gratitude to the previous Legal Advisers John Turnbull and Huw Rowlands.

### DISCUSSION WITH THE COUNSEL OF THE SPANISH COUNCIL OF STATE SR. TORRE DE SILVA

On 3 February 2004, the Counsel of the Spanish Council of State Sr Torre de Silva visited the Committee and made a short presentation on his work and the work of the Spanish Council of State. His presentation was followed by a discussion.

# DELAYS WITH SUBMISSIONS OF DRAFT STATUTORY INSTRUMENTS TO THE COMMITTEE

At the meeting on the 16 March 2004, the Legal Adviser informed the Members about the lack of time between the official submissions of Draft Statutory Instruments to the Legislation Committee and the Committee meetings, which made drafting reports on time very difficult. Quite often the Legal Advisers would get only two days to draft a report instead of the eight. The Legal Adviser suggested three options for addressing this problem:

- "if there is an insufficient time to draft a report, the consideration of the Statutory Instrument should be postponed accordingly;
- the Statutory Instrument is placed on agenda with a note that there was insufficient time to draft a report;
- the report is drafted late and, consequently, also sent late to Members." The Chair of the Committee wrote a letter to the Chair of the Business Committee pointing out the difficulty in meeting their requirements for consideration of Statutory Instruments if the fortnightly schedule was not observed. The timescale of submissions has subsequently improved.

#### STATUTORY INSTUMENTS ISSUED UNDER THE EXECUTIVE PROCEDURE

In April 2004, the Committee Members expressed concern that a significant proportion of legislation was issued under the Executive Procedure. Whilst the choice of procedure is primarily a matter for the Business Committee, the extended, standard (and accelerated) procedures permit full scrutiny by the Legislation Committee before Statutory Instruments are made. This includes the possibility of using Memoranda of Corrections to remedy any defects. Scrutiny of Instruments using the Executive Procedure only takes place after they are made, they cannot therefore be corrected without the making of further legislation.

It was noted that a number of the Explanatory letters stating the reasons for choice of the Executive procedure said that the up-to-date information about the necessity to issue a piece of legislation was released too late from UK Government Departments, making it impossible for the Assembly legislation to follow the full procedures and meet the deadline when it was required to come into force. The Chair wrote to the relevant Ministers querying the reasons for the delay in communications between Westminster and the Assembly. Following

reminder letters, the replies were received, but the Members noted that it was over one month after the Chair's letters were issued. They commented also that, although the Business Minister's letter provided explanations, it did not contain an assurance that in the future the Executive Procedure would be used only in exceptional cases. The Members decided that the Chair should write to relevant Ministers each time the Committee felt that it needed to clarify the reasons for the use of the Executive Procedure.

In her letter the Business Minister stated that her officials were in the process of preparing new guidance for Assembly officials on these issues. This guidance would address the concerns that the Legislation Committee had raised. The Chair wrote to the Business Minister to clarify the date when the guidance was going to be issued and the possibility for the Committee to contribute.

# DEDICATION OF CERTAIN PLENARY MEETINGS SOLELY TO DEBATES ON SUBORDINATE LEGISLATION

In May 2004, the Committee received a letter from the Chair of the Business Committee regarding a possibility of dedicating certain plenary meetings solely to debates on subordinate legislation. Earlier in the year the Business Managers discussed the issue with the Presiding Officers and there was a suggestion that instead of considering some subordinate legislation at most sessions, the Assembly could dedicate a whole plenary meeting to subordinate legislation. However, the Deputy Presiding Officer raised a concern that if a lot of legislation was submitted at the same time it would increase the pressure on the Legislation Committee as it might have to report on a great number of Statutory Instrument within a shortened period of time.

Following the discussion of this matter, the Chair of the Legislation Committee wrote to the Chair of the Business Committee highlighting the following points:

- although there were benefits in considering, for example, all regulations on Medical Contracts together in one plenary session, this would cause a large increase in the workload of the Legal Advisers to the Legislation Committee and the Committee's administrative staff, as large amount of legislation would be submitted to the Committee at the same time for draft reports to be produced within a day;
- the Members of the Legislation Committee already have to study a large amount of Draft reports and Draft Statutory Instruments in a short time period. If the proposal regarding the discussion of subordinate legislation in single dedicated sessions goes ahead, this could increase further.

# THE EDUCATION (PUPIL EXCLUSIONS AND APPEALS) (MISCELLANEOUS AMENDMENTS) (WALES) REGULATIONS 2004 (LC931)

On the 29 June 2004, the Committee discussed LC931 - The Education (Pupil Exclusions and Appeals) (Miscellaneous Amendments) (Wales) Regulations

2004 and a question was raised concerning the lack of definition of the word "practical" – the Members considered that the terminology was not tight enough. The consideration of this Draft Statutory Instrument was adjourned. An Explanatory Note was circulated to Members and on the 6 July 2004 an Assembly Counsel, Mr Andrew Felton and the Head of Pupil Engagement Team, Mr Graham Davies, attended the Committee meeting to answer questions in respect of this Statutory Instrument.

In discussion, it was pointed out that although, having read the Note with explanations, the Members fully understood the meaning of the word "practical", Members were concerned that the general public would experience difficulties when using the Regulations as they would not have seen the explanation. The Members decided that the Note should be published together with the Legislation Committee papers.

Mr Felton also confirmed that the Assembly would be publishing supplementary guidance to the existing guidance to explain the new provisions in the amending Regulations. Mr Graham Davies further informed the Committee that revised Guidance would issue soon. The Guidance has since been circulated to Members.

The Committee was grateful to Messrs Davies and Felton for their assistance, which demonstrated that officials working with the Committee could assist in making National Assembly legislation more accessible to its users.

# VISIT OF THE DELEGATION FROM THE SUBORDINATE LEGISLATION COMMITTEE OF THE SCOTTISH PARLIAMENT

On the 6 July 2004 the delegation from the Subordinate Legislation Committee of the Scottish Parliament attended the Committee meeting. The delegation comprised Convener of the Subordinate Legislation Committee of the Scottish Parliament Dr Sylvia Jackson MSP, Member of the Subordinate Legislation Committee of the Scottish Parliament Mr Stewart Maxwell MSP, Member of the Subordinate Legislation Committee of the Scottish Parliament Mr Gordon Jackson MSP, Legal Adviser to the Subordinate Legislation Committee of the Scottish Parliament, Ms Margaret Macdonald, Adviser to the Subordinate Legislation Committee of the Scottish Parliament on Inquiry into the regulatory framework in Scotland, Mr. Iain Jamieson, Clerk of the Subordinate Legislation Committee of the Scottish Parliament, Mr Alasdair Rankin.

The Convener of the Subordinate Legislation Committee of the Scottish Parliament gave an overview of the activities of her Committee and the issues concerning them, specifically paying attention to the Inquiry into the regulatory framework in Scotland that her Committee was undertaking. The Chair of the Legislation Committee, Glyn Davies AM, made a short presentation on the work of his Committee. The presentations were followed by discussion. The Head of

the Economic Development and Transport Business Unit, Mr David Hobbs, and his colleague, Ms Julie Hanley, took part in discussion, commenting on the steps being taken by the National Assembly for Wales to ensure that the Regulatory Appraisals were conducted and that their quality was satisfactory.

#### **Statutory Instruments Considered by the Legislation Committee**

LC682 The Housing (Right to Buy) (Limits of Discount) (Amendment) (Wales) Order 2003

Considered by the Legislation Committee on: 10<sup>th</sup> June 2003

The Committee did not identify any points reportable under S.O. 11.7.

These defects were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13. The Committee did not identify any points reportable under S.O.11.7. The legal advisers to the Committee had had the opportunity to consider an early draft when some points had been identified and subsequently corrected.

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. Under Observations the Committee noted that there was also a minor inconsistency between the English and the Welsh texts in article 1(3)(b), - this could also be corrected by the Memorandum of Corrections.

LC814 The Adoption and Children Act 2002 (Commencement No.5) (Wales) Order 2004

Considered by the Legislation Committee on: 20<sup>th</sup> January 2004

The Committee identified two points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: the reference to section 139(2) should be removed from the Order and the scope of the provision commenced should be limited to 62(7)(c) and the corresponding provision in section 61(5)(c) should also be commenced. Under Observations the Committee commented that the note on the earlier commencement orders should follow immediately after the Explanatory Note, this could be done in printing; the note on the earlier orders was confusing - it would have been easier if the table contained only those provisions previously brought into force in relation to Wales followed by a short paragraph listing simply the orders made in relation to other parts of the United Kingdom without item missing the provisions commenced.

LC815 The Food (Emergency Control) (Miscellaneous Amendments) (Wales) Regulations 2004

Considered by the Legislation Committee on: 27th January 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. This was appropriate for correction by means

of a Memorandum of Corrections under S.O.24.13: the coming into force date should be changed to allow for consideration in plenary. Under Observations the Committee noted a small number of points relating to the Explanatory Note, footnotes and formatting appropriate for correction on publication.

LC816 The Council Tax (Demand Notices) (Amendment) (Wales)
Regulations 2004

Considered by the Legislation Committee on: 20<sup>th</sup> January 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. This was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: paragraph 1 of Schedule 2 to the Local Government Finance Act 1992 should have been added to all the powers cited in relation to the Council Tax (Demand Notices) (Wales) Regulations 1993. Under Observations the Committee noted that the title of the Regulations should be amended to "The Council Tax (Demand Notices) (Wales) (Amendment) Regulations 2004", this could also be addressed by the Memorandum of Corrections referred to above.

LC817 The Housing Renewal Grants (Amendment) (Wales) Regulations 2004

The Committee did not identify any points reportable under S.O.11.7.

LC818 The Housing Renewal Grants (Prescribed Form and Particulars) (Amendment) (Wales) Regulations 2004

The Committee identified four points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: in the Welsh text of paragraph 7 of the Schedule the words "2 i 2C" should read "2A i 2C"; in paragraph 12(b) of the Schedule in the Welsh text the words "yn lle" should read "ar ôl" as this is an addition and not a substitution; the introduction to paragraph 21 of the Schedule should be in Welsh in the Welsh column: "Yn lle Nodiadau 16 i 19 rhowch – " and in paragraph 30 of the Schedule in the Welsh text the words "Nodyn 55(a)" should read "Nodyn 55(a) a (b)". Under Observations the Committee noted a number of minor points in relation to the Explanatory Note, footnotes and punctuation.

LC819 The Domiciliary Care Agencies (Wales) Regulations 2004

Considered by the Legislation Committee on: 27th January 2004

The Committee identified a number of points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: throughout the Regulations eighteen discrepancies between the Welsh and English text were identified and regulation 3(1)(c) contained a drafting error: it inappropriately referred to a prospective piece of Assembly legislation. Under Observations the Committee noted that the Regulations contained a number of spelling and formatting points appropriate for correction on publication.

LC820 The Food (Provisions relating to Labelling) (Wales) Regulations 2004

Considered by the Legislation Committee on: 27th January 2004

The Committee identified two points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: in the Welsh text of regulation 1(1), "2003" needed to be changed to "2004" and in the new regulation 34A(1)(b) (inserted in the 1996 Regulations by regulation 6) there was an inconsistency between the English and the Welsh texts. The Committee also observed that the Regulations contained other examples where updating was needed, but as these errors were not to the operative parts of the Regulations that would have to be done on publication. Under Observations the Committee noted that references to Community legislation needed updating; this could also be addressed by the Memorandum of Corrections and that the legal adviser to the Committee had had the opportunity to consider an early draft when some points relating to the Explanatory Note, footnotes, spelling and formatting had been identified as appropriate for correction on publication.

LC821 The Removal of Obstructions from Highways (Wales) Regulations 2004

Considered by the Legislation Committee on: 27<sup>th</sup> January 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. The point was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: there was an inconsistency between the English and the Welsh texts at the end of Form 5 set out in the Schedule. Under Observations the Committee noted that the legal adviser to the Committee had had the opportunity to consider an early draft when

a number of spelling and formatting points had been identified as appropriate for correction on publication.

LC822 The Countryside and Rights of Way Act 2000 (Commencement No.4) (Wales) Order 2004

Considered by the Legislation Committee on: 27th January 2004

The Committee did not identify any points reportable under S.O.11.7.

LC823 The Infant Formula and Follow-on Formula (Amendment) (Wales) Regulations 2004

Considered by the Legislation Committee on: 3<sup>rd</sup> February 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. The point was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: the power contained in Section 6(4) of the Section 6 of the Food Safety Act 1990 was particularly relevant in relation to regulation 8 of the current Regulations and should have been added to other powers. Under Observations the Committee noted that in regulation 5 both the phrases in quotation marks used "a" when it should read "and".

LC824 The Health Professions Wales (Establishment, Membership, Constitution and Functions) Order 2004

Considered by the Legislation Committee on: 3<sup>rd</sup> February 2004

The Committee identified a number of points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: in article 1(1) the title of the Order required updating in both languages and there were eight inconsistencies between the English and the Welsh texts in the Regulations. Under Observations the Committee noted that the legal adviser to the Committee had had the opportunity to consider an early draft when a number of points relating to the Explanatory Note, footnotes, spelling, punctuation and formatting had been identified as appropriate for correction on publication.

LC825 The Health Professions Wales (Transfer of Staff, Property, Rights and Liabilities Order 2004

Considered by the Legislation Committee on: 3<sup>rd</sup> February 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that there was a drafting error in the Welsh text of the Schedule and that the legal adviser to the Committee had had the opportunity to consider an early draft when a small number of points relating to footnotes, spelling and formatting had been identified as appropriate for correction on publication.

LC826 The Processed Cereal-based Foods and Baby Foods for Infants and Young Children (Wales) Regulations 2004

Considered by the Legislation Committee on: 3<sup>rd</sup> February 2004

The Committee identified a number of points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13:

- the power contained in section 6(4) of Section 6 of the Food Safety Act 1990 dealt with enforcement and was particularly relevant in relation to regulation 9 of the current Regulations. That power should be added to other powers;
- there was a discrepancy between the Welsh and English texts in regulation 6(3) and the numbering was incorrect (the numbering could be corrected on publication);
- in regulation 12, the entries for section 35(2) and (3) did not correspond;
- in paragraph 1 of Part II of the Welsh version of Schedule 1 there two references should be "gynhyrchion gwreiddiau startslyd" and "cynnyrch gwreiddiau startslyd" in turn;
- in both languages paragraph 6.2 of Part II of Schedule 1 had some missing text immediately before the table, such as "the following limits apply";
- in Schedule 4, the entry for "Calcium L-ascorbate" in Welsh should read "Calsiwm L-asgorbad".

Under Observations the Committee noted that the legal adviser to the Committee had had the opportunity to consider an early draft when a small number of points relating to the 'other language' terms in the definitions in regulation 2(1) and to numbering and formatting had been identified as appropriate for correction on publication.

LC827 The Water Industry (Prescribed Conditions) (Wales) Regulations 2004

Considered by the Legislation Committee on: 27<sup>th</sup> January 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. The point was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: the title in regulation 1(1) should be amended to include wording such as "(Undertakings wholly or mainly in Wales)" and consequential amendments to the non-operative parts of

the Regulations should be made. Under Observations the Committee noted that a footnote defining the term "the Director" as used in regulation 3(3)(a) would be helpful to the reader. The Committee also noted that regulation 1(2) provided that these Regulations applied to water or sewerage undertakers whose area was wholly or mainly in Wales and therefore these Regulations should be laid before Parliament after they have been made by the National Assembly. It was presumed that this was the reason that the Minister had considered it appropriate to make these Regulations in English only.

LC828 The Education (Individual Pupil Information) (Prescribed Persons) (Wales) Regulations 2004

Considered by the Legislation Committee on: 10<sup>th</sup> February 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. The point was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: there was one minor drafting error in the English title given in regulation 1(1) (the words "(Prescribed Persons)" were missing).

LC829 The Jam and Similar Products (Wales) Regulations 2004

Considered by the Legislation Committee on: 10<sup>th</sup> February 2004

The Committee identified two points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: there were two inconsistencies between the English and the Welsh texts. Under Observations the Committee noted that a small number of other points relating to the Explanatory Note, footnotes, spelling and formatting appropriate for correction on publication.

LC830 The Miscellaneous Food Additives (Amendment) (Wales)
Regulations 2004

Considered by the Legislation Committee on: 10<sup>th</sup> February 2004

The Committee did not identify any points reportable under S.O. 11.7. Under Observations the Committee noted a small number of other points relating to the Explanatory Note, footnotes, plurals, punctuation and formatting appropriate for correction on publication.

LC831 The Commonhold and Leasehold Reform Act 2002 (Commencement No.2 and Savings) (Wales) Order 2004

Considered by the Legislation Committee on: 24th February 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted a few typographical errors appropriate for correction on publication.

LC832 The Leasehold Valuation Tribunals (Fees) (Revocation and Savings) (Wales) Order 2004

Considered by the Legislation Committee on: 24th February 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted two minor points in relation to the Explanatory Note and errors in punctuation appropriate for correction on publication.

LC833 The Leasehold Valuation Tribunals (Service Charges, Insurance or Appointment of Managers Applications) (Revocation and Saving) (Wales) Order 2004

Considered by the Legislation Committee on: 24th February 2004

The Committee did not identify any points reportable under S.O.11.7.

LC834 The Leasehold Valuation Tribunals (Fees) (Wales) Regulations 2004

Considered by the Legislation Committee on: 24th February 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted the Welsh text of regulation 8(4)(a) needed clarification. Also, the Committee noted a couple of minor typographical errors appropriate for correction on publication.

LC835 The Leasehold Valuation Tribunals (Procedure) (Wales) Regulations 2004

Considered by the Legislation Committee on: 24th February 2004

The Committee identified several minor drafting points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: there were discrepancies between the Welsh and English texts in regulation 4(2), paragraph 11(4)(a), paragraph 13(4), paragraph 14(3), paragraph 14(5), paragraph 14(7)(a), the final part of paragraph 14(7)(b), paragraph 16(1)(a),

paragraph 16(1)(b), paragraph 23(5(b), paragraph 11(7) of Schedule 2. Under Observations the Committee noted a number of other points relating to the Explanatory Note and footnotes, spelling, punctuation and formatting, appropriate for correction on publication. The Committee also expressed its surprise that the Regulations made no provisions in relation to the language of any hearing.

LC836 The RTM Companies (Memorandum and Articles of Association) (Wales) Regulations 2004

Considered by the Legislation Committee on: 24th February 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly: the introductory paragraph following the reference to the Welsh Language Act 1993 needed clarification; both the English and the Welsh Memorandum and Articles should have provided for just one legal name of the company, which could be in either language; the signature details at the end of both documents should have required the names and addresses of witnesses; in the first line of paragraph 4(h) of the Welsh text of Schedule 2 the word "gan" was superfluous; in the Welsh text, the second line of paragraph 4(ph) and the first line of paragraph 4(th) of Schedule 2 needed clarification. Under Observations the Committee noted a small number of other points relating to typographical errors appropriate for correction on publication.

LC837 The Leasehold Reform (Enfranchisement and Extension)
(Amendment) (Wales) Regulations 2004

Considered by the Legislation Committee on: 24th February 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted a small inconsistency between the English and the Welsh texts in the preliminary paragraph the power cited to make the Regulations; regulation 2(a) needed clarification; a couple of other points relating to the Explanatory Note and footnotes appropriate for correction on publication.

LC838 The Leasehold Reform (Collective Enfranchisement and Lease Renewal) (Amendment) (Wales) Regulations 2004

Considered by the Legislation Committee on: 24th February 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. The point was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: there was an inconsistency between the English and the Welsh texts in regulation 2(b).

LC839 The Right to Manage (Prescribed Particulars and Forms) (Wales) Regulations 2004

Considered by the Legislation Committee on: 24th February 2004

The Committee identified two points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: the reference in 3(2)(c) of the Welsh text should be corrected to (d); there was an inconsistency between the English and the Welsh texts in regulation 3(2)(ch), the Welsh text of regulation 6(a) needed clarification; in the Welsh text, the italicised notes in paragraph 4 of the Schedule in the form set out in Schedule 1 needed clarification; in the Welsh text of paragraph 2 of Schedule 2, the reference to "mangre" needed clarification. Under Observations the Committee noted a few other minor points relating to the Explanatory Note and footnotes, and numbering and punctuation, appropriate for correction on publication.

LC840 The Service Charges (Consultation Requirements) (Wales)
Regulations 2004

Considered by the Legislation Committee on: 24th February 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: in the Welsh version: regulation 3(1)(b) needed clarification; there was a typographic mistake in paragraph 3 and in paragraph 4(3) of Schedule 1; paragraph 5(11) of Schedule 1 and paragraph 4(3) of Schedule 2 contained some defective drafting; paragraph 5(10)(a)(ii) of Schedule 1 contained an inconsistency between the English and the Welsh texts. Under Observations the Committee noted a number of other points relating to the Explanatory Note and footnotes, punctuation and formatting appropriate for correction on publication.

LC841 The Vehicular Access Across Common and Other Land (Wales)
Regulations 2004

Considered by the Legislation Committee on: 9th March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted a couple of formatting points appropriate for correction on publication.

LC842 The Water Industry (Prescribed Conditions) (Undertakers Wholly or Mainly in Wales) Regulations 2004

## Considered by the Legislation Committee on: 24th February 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that these Regulations previously came before the Committee on the 27<sup>th</sup> January, and matters identified in that earlier version had all been appropriately dealt with in this revised version. Standing Order 23.13 provides that legislation made under that Standing Order (of which this was an example) is to be translated into Welsh and the translation published for public information unless the Minister considers it inappropriate in the circumstances or not reasonably practicable.

LC843 The Education (School Inspection) (Amendment) (Wales)
Regulations 2004

Considered by the Legislation Committee on: 2<sup>nd</sup> March 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. The point was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: the Welsh text of article 1(1) had 2003 in the title of the Regulations. Under Observations the Committee noted that these Regulations should more appropriately have been called "The Education (School Inspection) (Wales) (Amendment) Regulations 2004" as they amended existing Wales only legislation, "The Education (School Inspection) (Wales) Regulations 1998".

LC844 The Inspection of Education and Training (Amendment) (Wales)
Regulations 2004

Considered by the Legislation Committee on: 2<sup>nd</sup> March 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. The point was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: as the current Regulations amended the Inspection of Education and Training (Wales) Regulations 2001, the powers relied upon should have been included. Under Observations the Committee noted that these Regulations should more appropriately had been called "The Inspection of Education and Training (Wales) (Amendment) Regulations 2004" as they amended existing Wales only legislation.

LC845 The Common Agricultural Policy Non-IACS Support Schemes (Appeals) (Wales) Regulations 2004

Considered by the Legislation Committee on: 2<sup>nd</sup> March 2004

The Committee identified several points relating to the Welsh Schedule, which were reportable under S.O.11.7 and to which it drew special attention of the Assembly: reference to Regulation (EC) 2826/2000 of the Welsh description should be standardised; "EC" had been extended to "EEC" which should be corrected; one E had been omitted from the reference to Regulation 1766/92 at the top of the fourth page of the Schedule and in the same paragraph "(Erthyglau 7 ac 8)" had been omitted; on the fifth page an incorrect description of Regulation 1260/2001 had been given; in the Welsh language version of the Regulations, "ei ddiwygiwyd" should be replaced by "y'i diwygiwyd" wherever it occurred. Under observation the Committee noted a number of formatting and punctuation points, and other points relating to the footnotes, appropriate for correction on publication.

LC846 The Inspection of Youth Support Services in Wales Regulations 2004

Considered by the Legislation Committee on: 2<sup>nd</sup> March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted a small number of other points relating to the Explanatory Note, punctuation and footnotes appropriate for correction on publication.

LC847 The Care Standards Act 2000 (Extension of Meaning of "Social Care Worker") (Wales) Regulations 2004

Considered by the Legislation Committee on: 2<sup>nd</sup> March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that these Regulations did not contain an application provision as they simply extended a definition for the purpose of the registration functions of the Care Council for Wales and the application had been dealt with in other legislation. The Committee also noted a couple of formatting points appropriate for correction on publication.

LC848 The Care Council for Wales (Specification of Student Social Workers) (Registration) Order 2004

Considered by the Legislation Committee on: 2<sup>nd</sup> March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that this Order did not contain an application provision because it simply extended the scope of the registration functions of the Care Council for Wales, the geographical application of which was dealt with in

other legislation and that it had been necessary to make separate Statutory Instruments as the relevant powers contained in the Care Standards Act provided that they were to be exercised "by order" and that "Regulations may prescribe" respectively. The Committee also noted a couple of formatting points and one relating to a footnote appropriate for correction on publication.

LC849 The Food (Hot Chilli and Hot Chilli Products) (Emergency Control) (Amendment) (Wales) Regulations 2004

Considered by the Legislation Committee on: 9th March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that these Regulations should more appropriately have been called "The Food (Hot Chilli and Hot Chilli Products) (Emergency Control) (Wales) (Amendment) Regulations 2004" as they amended existing Wales only legislation - "The Food (Hot Chilli and Hot Chilli Products) (Emergency Control) (Wales) Regulations 2003". The Committee also noted that the Explanatory Note needed further clarification.

LC850 The Local Authorities (Alteration of Requisite Calculations) (Wales)
Regulations 2004

Considered by the Legislation Committee on: 16th March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted a small number of formatting points appropriate for correction on publication.

LC851 The Council Tax (Prescribed Classes of Dwellings) (Wales)
Regulations 2004

Considered by the Legislation Committee on: 16th March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted a couple of typographical errors not relating to the operative part of the Regulations which were appropriate for correction on publication.

LC852 The Library Advisory Council for Wales Abolition and Consequential Amendments Order 2004

Considered by the Legislation Committee on: 9th March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that it would be necessary to remove the reference to the Council from the "The National Assembly for Wales (Disqualification) Order 2003" and that the Welsh text contained superfluous brackets in the title of the Order.

LC853 The Education (Induction Arrangements for School Teachers) (Amendment) (Wales) Regulations 2004

Considered by the Legislation Committee on: 9th March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that these Regulations should more appropriately have been called "The Education (Induction Arrangements for School Teachers) (Wales) (Amendment) Regulations 2004" as they amended existing Wales only legislation - "The Education (Induction Arrangements for School Teachers) (Wales) Regulations 2003". The Committee also noted a few formatting points appropriate for correction on publication.

LC854 The Community Health Councils Regulations 2004

Considered by the Legislation Committee on: 9th March 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13:

- the definitions had three inconsistencies between the English and the Welsh texts:
- the Welsh text of the regulation 2(1), regulation 2(2), regulation 14(1) and regulation 27(1) needed further clarification;
- regulation 6(1) needed further clarification;
- the wording of regulation 6(2) should be simplified;
- regulation 7(a), regulation 19(1) and paragraph 5 of the Schedule contained inconsistencies between the English and the Welsh texts;
- regulation 9(1) needed the words "Subject to paragraph (4)" / "Yn ddarostyngedig i baragraff (4)" removed;
- in regulation 9(2) "(4)" should be replaced by "(3)";
- regulation 11(2) should have a reference to giving "hysbysiad ysgrifenedig" rather than "rhybudd ysgrifenedig";
- in the Welsh text of regulation 16(1)(a), the reference to "reoliad 21" should read "reoliad 22";

- in regulation 18(1) the words "a relevant NHS body or bodies" / "corff neu gyrff GIG perthnasol" should be replaced by "a relevant NHS body" / "corff GIG perthnasol";
- in the Welsh text of regulation 26(2)((a), the reference to "any vehicle" in the English text is missing.

Under Observations the Committee noted that it would be of assistance to those considering legislation, if "(Wales)" were included in the title; regulation 20(1)(f) contained inconsistencies between the English and the Welsh texts, needing the insertion of explanatory footnotes. The Committee also noted a number of punctuation and formatting points appropriate for correction on publication.

LC855 The Welsh Development Agency (Derelict Land) Order 2004

Considered by the Legislation Committee on: 9th March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted a couple of minor points relating to the explanatory note and article headings (which do not form part of the substance of the order) appropriate for correction on publication.

LC856 The Council Tax (Demand Notices) (Wales) (Amendment)
Regulations 2004

Considered by the Legislation Committee on: 9th March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted a small number of very minor points relating to the Explanatory Note appropriate for correction on publication.

LC857 The Health and Social Care (Community Health and Standards) Act 2003 Commencement (No.1)(Wales) Order 2004

Considered by the Legislation Committee on: 30th March 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of an Amendment Order: article 1(2)(b) needed further clarification; article 3(1)(a) contained a drafting defect; in article 4(2)(b), "paragraphs (c) and (d)" should replace "paragraph (iii) and (iv)"; article 4(2)(l) duplicated provisions referred to in article 4(2)(k) and could be omitted. Under Observations the Committee noted that a second commencement Order had been made on behalf of the National Assembly on the 23<sup>rd</sup> March, also using the Executive procedure.

LC858 The National Health Service (General Medical Services Contracts) (Wales) Regulations 2004

Considered by the Legislation Committee on: 27th April 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The Committee considered that although none of the highlighted matters would, on its own, have required the immediate drafting of correcting legislation, these Regulations formed the basis for the contracts of general practitioners and therefore they should be corrected as soon as possible:

- the paragraph which recites the powers under which the Regulations have been made wrongly referred to section 28D(1)(bc) of the National Health Service Act 1977;
- the definition of "adjudicator" in regulation 2(1) contained an incorrect reference to paragraph 101(5) of Schedule 6 (to these Regulations) the reference should have been to paragraph 99(5);
- paragraph (a) should be removed from the definition of "GP registrar" in the same regulation;
- in regulation 5(2)(h) the reference to Scottish legislation should be to the Criminal Procedure (Scotland) Act 1995;
- regulation 10 (2) was difficult to follow as it currently drafted as there was an unnecessary "it" and a mis-placed comma;
- paragraphs (2), (3) and (4) of regulation 17 made reference to paragraph 4(8) of Schedule 3 insofar as it related to paragraph 3(12)(2)(14). Paragraph 4(8) did not relate to paragraphs 3(12) to (14), whereas paragraph 4(9) did;
- in regulation 23, the words "payments of" appeared incorrectly in the middle of the reference to section 28T of the Act;
- in the same regulation, the brackets before the word "Assembly's" should be opened;
- regulation 24(4) wrongly referred to paragraph (e) of Schedule 5;
- paragraph 11, paragraph 36(13), paragraph 89, the final part of paragraph 103(2) of Schedule 6, paragraph 5 of Schedule 7 contained drafting errors and should be revised;
- paragraph 19(5) contained erroneous cross-referencing;
- paragraph 48(6), paragraph 102(1), paragraph 111(2)(e) of the Schedule 6 needed further clarification;
- the heading for Schedule 8 should be cross-referenced to Schedule 6 paragraph 9;
- the heading to Schedule 10 should be cross-referenced to paragraph 75 of Schedule 6 and not paragraph 76.

Under Observations the Committee noted a number of other minor points in relation to footnotes, formatting, spelling, punctuation and capitalisation suitable for correction on publication.

LC859 The General Medical Services Transitional and Consequential Provisions (Order) (Wales) 2004

Considered by the Legislation Committee on: 27th April 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points would have been appropriate for correction by means of a Memorandum of Corrections, but as the Order had already been made, consideration would need to be given as to whether amending legislation was necessary: a number of the definitions needed further clarification; article 4(3), article 5(c), article 12(b), article 20(4), article 21(a) and article 22(b)(ii) contained drafting errors. Under Observations the Committee noted a number of other minor points in relation to footnotes, formatting, spelling, punctuation and capitalisation that would have been suitable for correction on publication.

LC860 The Dairy Produce Quotas (Wales) (Amendment) Regulations 2004

Considered by the Legislation Committee on: 16th March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted a number of minor formatting and typographical errors appropriate for correction on printing.

LC861 The Water Act 2003 (Commencement) (Wales) Order 2004

Considered by the Legislation Committee on: 16<sup>th</sup> March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted a couple of formatting points appropriate for correction on publication.

LC862 The Litter and Dog Fouling (Fixed Penalty) (Wales) Order 2004

Considered by the Legislation Committee on: 16th March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that two separate draft orders dealing with these issues had been considered by the Committee at it's meeting on the 2<sup>nd</sup> December 2003, when the Committee had indicated a preference for a combined

order and had asked that Parliamentary Counsel's advice be sought regarding the precise wording, having regard to concerns expressed by the legal adviser. This Order was the result of further consideration of those matters.

LC863 The Education (School Organisation Proposals) (Wales) (Amendment) Regulations 2004

Considered by the Legislation Committee on: 16<sup>th</sup> March 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. The point was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: in paragraph 18A(i) there was a typographical error. Under Observations the Committee noted that in the first line of the Explanatory Note, the title of the 1999 Regulations being amended was incorrect in both languages; the correct name appeared in regulation 2.

LC864 The National Health Service (Pharmaceutical Services etc)
(Repeatable Prescriptions) (Amendment)(Wales) Regulations 2004

Considered by the Legislation Committee on: 16th March 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: regulation 6(3)(n) needed further clarification; the second line of the proposed regulation 3A(7) contained an inconsistency between the English and the Welsh texts; regulation 8(6)(b) contained a drafting defect. Under Observations the Committee noted a number of points relating to the Explanatory Note, footnotes and formatting.

LC865 The National Health Service (General Medical Services Contracts) (Prescription of Drugs etc.) (Wales) Regulations 2004

Considered by the Legislation Committee on: 16th March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that these Regulations had been submitted to the Legislation Committee in English only and followed the Whitehall format.

LC866 The National Health Service (Performers Lists) (Wales) Regulations 2004

Considered by the Legislation Committee on: 16th March 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: a new definition of "Services List Regulations" in regulation 2 was required; regulation 4(1), regulation 4(6), paragraph (a) of regulation 13(7), paragraph (a) of regulation 21, regulation 23(2)(b)(iii)(aa) and 23(3)(c)(i) needed further clarification; regulation 9(2), regulation 17(2), regulation 20(h), regulation 20(i), regulation 24(1)(d), regulation 24(2)(b), regulation 24(2)(c) contained drafting defects; references to a "Fitness to Practice Panel" should read "Fitness to Practise Panel". Under Observations the Committee noted that regulation 6(2)(b) correctly referred to the knowledge of English, without referring to the knowledge of Welsh: this reflected a provision in the primary legislation. The Committee noted that reference was made to the National Health Service (General Medical Services Contracts) (Wales) Regulations 2004 and therefore those Regulations would need to be made before, or at the same time, as the current Regulations. The Committee noted a number of points relating to the Explanatory Note, footnotes and formatting.

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that the C. (Commencement) number should precede the W./Cy (Wales/Cymru) number – paragraph 2.3.3 of the Statutory Instrument Practice.

The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: in the Welsh text of this Order: "magu" should be changed to "bridio" wherever it occurs; there were drafting defects in article 3, article 4(3), article 21(1)(a) and article 28; in article 4(3) "yn ychwanegol" (in addition) was incorrect - it should be replaced by "neu ychwanegiad" (or addition); article 9(1) contained an inconsistency between the English and the Welsh texts; in article 11(dd) "ynghlwm wrth" should be used to correspond to "attached to"; "ynghlwm wrtho" in the latter article should be replaced by "gydag ef"; in article 15(2)(a) "ynghlwm wrth y" should be replaced by "gyda'r". Under Observations the Committee noted a small number of minor points relating to formatting and footnotes and appropriate for correction on publication.

LC871 The Education Act 2002 (Commencement No.4 and Transitional Provisions)(Wales) Order 2004

Considered by the Legislation Committee on: 16th March 2004

The Committee did not identify any points reportable under S.O.11.7.

LC872 The Education (Pupil Information) (Wales) Regulations 2004

Considered by the Legislation Committee on: 23rd March 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: the provisions of section 408 of the Education Act 1996 should be excluded from the parts of these Regulations that rely on the power in section 408; amendments would need to be made to regulations 7, 8 and 9, and to the definition of "maintained school" in regulation 2(1); regulation 2(3) and paragraph 5(1) of Schedule 2 contained inconsistencies between the English and the Welsh texts. Under Observations the Committee noted a few points relating to footnotes and formatting which were appropriate for correction on printing.

LC873 The Education (School Performance Information)(Wales)

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: throughout the regulations the inconsistencies between the English and Welsh terminology (e.g., the term "National Assembly", "in accordance with the statutory assessments") needed to be addressed; the Welsh text of regulation 6, regulations 10 and 11, paragraph 4 of Schedule 2, paragraphs 1(2)(b), (2)(c), (2)(ch) and (2)(d); paragraphs 2(2)(a), (2)(b), (2)(c) and (2)(d), paragraphs 3(c) and 4(c) of Schedule 3 contained various drafting errors. Under Observations the Committee noted a number of minor points relating to formatting and typographical errors suitable for correction on printing.

LC874 The Adoption Support Services (Local Authorities) (Wales)
Regulations 2004

Considered by the Legislation Committee on: 23rd March 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: throughout the regulations the Welsh term for "a child who is looked after" should be changed to "plentyn sydd yn derbyn gofal"; there was an inconsistency between the English and Welsh texts in regulation 2(3); the Welsh text of regulation 3(2), regulation 5(3), regulation 9(5) and regulation 13(c)(iii) needed clarification; the Welsh text of regulation 4(1), regulation 5(9) and paragraphs 11(2) (b) (ch) contained drafting defects; regulation 6(4) and regulation 6(6) contained a number of wrong references both in the English and Welsh texts; the English text of regulation 6(5)(b), regulation 7(2)(c) and the third line of 10(2)(e) contained a drafting defects; in the Welsh text, cross references needed to be changed to accommodate the different lettering of paragraphs. Under Observations the Committee noted a number of formatting points and spelling mistakes appropriate for correction on publication.

LC875 The Local Authorities (Capital Finance and Accounting)(Wales)
(Amendment) Regulations 2004

Considered by the Legislation Committee on: 23rd March 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted two minor points in relation to the Explanatory Note and footnotes appropriate for correction on printing.

LC876 The Non-Domestic Rating (Miscellaneous Provisions) (Amendment) (Wales) Regulations 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that the Order as signed did not have the usual Schedule of provisions previously commenced, as included in the Assembly's earlier Commencement Order in respect of provisions previously commenced by the Secretary of State - these provisions should be added on publication.

- in the Explanatory Note, the Welsh title of the "Petitions and Directions Regulations" was mistyped;
- the paragraph in the Explanatory Note relating to regulation 8 contained inconsistencies between the English and the Welsh texts;
- the Welsh text of Explanatory Note's reference to regulation 20 and regulation 20 as well as paragraph 1 of Schedule 2; regulation 8; the headings of column 2 of Tables 2 and 3; the modification of section 30 of the 1983 Act contained drafting errors;
- in Table 2, the modification "Omit mentioned in subsections (1) or (3)" should be deleted:
- the translation of "citizen of the Union" and "relevant citizen of the Union" did not appear to be correct in that "dinesydd I'r Undeb" and "dinesydd perthnasol I'r Undeb" implied "to the" rather than "of the Union".

The Committee also noted a number of formatting points and spelling errors, together with points relating to footnotes, appropriate for correction on publication.

Under Observations the Committee a number of other minor points in relation to footnotes, formatting, spelling, punctuation and capitalisation suitable for correction on publication (but not by a correcting instrument).

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that the identifying letters ascribed to the various Statutory Instruments referred to in Welsh text in the Explanatory Note must be converted to the Welsh alphabet; that could be done on publication.

The Committee did not identify any points reportable under S.O.11.7.

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly: in a number of the definitions the references should be to " the National Health Service Act 1977 Act" and not to the "1977 Act"; in articles 71 and 73 the references should be to " that Local Health Board" and not to "that Trust"; in respect of regulations 15 to 18, the provisions succeeding article 76 should follow the pattern set in article 76; the reference to regulation 11(5) in article 77(4) should be omitted. Under Observations the Committee noted that paragraph 35 of Schedule 1 made changes to the General Medical Services Transitional and Consequential Provisions (Wales) Order 2004 and some of the amendments dealt with issues referred to in the report on that earlier Order.

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: there were inconsistencies between the English and Welsh texts: in respect of the definition of "port health authority"; in regulation 3(2)(b) in respect of "consumption by babies or young children"; in regulation 5(3) in respect of the words "no account shall be taken of"; in regulation 7(1) in respect of the words "contravenes or fails to comply with regulation 4, 5(2) or 6(1) of these Regulations" and the levels of penalties; in regulations 7(2) and 7(3) in respect of the words " each.... authority shall enforce"; also, the Welsh text of regulation 6(1) contained drafting defects. Under Observations the Committee noted that in regulation 8, the paragraphs in the Welsh text followed the English alphabet. The Committee observed that there was also a number of minor typographical and formatting errors were suitable for correction on printing.

LC897 The National Health Service (Charges to Overseas Visitors) (Amendment) (Wales) Regulations 2004

Considered by the Legislation Committee on: 18th May 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. The point was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: the reference to the regulation in the definition of "the United Kingdom Government" inserted into regulation 1 of the principal Regulations should read 4(1)(a)(iii) rather than 4(a)(iii). Under Observations the Committee noted that instead of amending the existing legislation in regulation 6, the more common approach would have been to insert a different regulation 6A for Wales. The Committee also noted a small number of spelling and formatting points suitable for correction on printing.

Another point was raised in respect of article 5, which contained a reference to the wrong commencement date.

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted a small number of points relating to footnotes and formatting appropriate for correction on printing.

Under Observations the Committee noted one additional point which would need to be included in a Memorandum of Corrections under S.O.24.13: in the Welsh regulation 13(2) after "mewnosoder y" there should be inserted "geiriau" to correspond to "words" in the English text. The Committee also noted a number of points relating to the Explanatory Note and footnotes, formatting and spelling suitable for correction on printing.

The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: definition of "gwasanaethau gofal" in regulation 2(1) and the subsequent definition of "oedolyn hawdd ei niweidio"; regulation 5(1)(a); the Welsh text of regulation 8(4)(a); regulation 15(2); regulation 30(ch)(i); regulation 33; the second line of paragraph 2 of Schedule 1; the first line of paragraph 4(b) of Schedule 1 contained drafting errors; at the end of regulation 11(2) the words "sicrhau y darperir y cynllun â gofal, cymhwysedd a sgil digonol" should have been used instead of the words "sicrhau y darperir y cynllun a'r gofal, cymhwysedd a'r sgil digonol"; regulation 23(5)(a) contained an inconsistency between the English and Welsh texts. Under Observations the Committee noted a number of other minor formatting points, or relating to headings, the Explanatory Note or footnotes appropriate for correction on printing.

Regulations 2004

Considered by the Legislation Committee on: 22<sup>nd</sup> June 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. The point was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: in regulation 2(2), the definition of ""GCE 'A' level examinations" and "GCE AS"" contained a minor drafting error. Under Observations the Committee noted whilst it was not strictly a reporting point, the draft would have been enhanced by use of the "in the appropriate alphabetical order" in the opening words of regulation 2(2); in the Welsh text, the closing quotation mark was missing at the end of regulation 2(2).

LC918 The School Governors' Annual Reports (Wales) (Amendment)
Regulations 2004

Considered by the Legislation Committee on: 22<sup>nd</sup> June 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. The point was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: the wording in regulation 2(2) of the definition of "GCE 'A' level" and "GCE 'AS level examinations'" needed further clarification. Under Observations the Committee noted whilst it was not strictly a reporting point, the draft would have been enhanced by use of the "in the appropriate alphabetical order" in the opening words of regulation 2(2); in the Welsh text, the closing quotation mark was missing at the end of regulation 2(2).

LC919 The Care Standards Act 2000 (Commencement No.14) (Wales)
Order 2004

Considered by the Legislation Committee on: 22<sup>nd</sup> June 2004

The Committee identified one point reportable under S.O.11.7 to which it drew special attention of the Assembly. The point was appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: the sections to be commenced by article 2 needed clarification: they had previously been commenced for various purposes, most recently by the Commencement No.13 Order.

LC920 The Children (Leaving Care) (Amendment) (Wales) Regulations 2004

Considered by the Legislation Committee on: 22<sup>nd</sup> June 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: the title of these Regulations should be "The Children (Leaving Care) (Wales) (Amendment) Regulations 2004"; in regulation 2, there was incorrect use of "paragraph" and "subparagraph"; the heading should read "Amendment of regulation 4 of the Principal Regulations"; in the final line of regulation 2(1), "paragraph" was correctly used in relation to 2A, but to match the numbering of other paragraphs, the 2A should be in brackets; in regulation 2(2), the inserting expression should read "after paragraph (2)" and the reference in the second line of the insertion should be to "sub-paragraph (2)(b)"; in the standard signature block the words "Date" and "Dyddiad" should be inserted.

LC921 The Wales Centre for Health (Constitution, Membership and Procedures) Regulations 2004

Considered by the Legislation Committee on: 22<sup>nd</sup> June 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: in regulation 2(4), regulation 6(6), regulation 10(2) and paragraph 4 of the Schedule there were inconsistencies between the English and Welsh texts; regulation 5, regulation 6 and the Welsh text of regulation 5(a) contained drafting defects. Under Observations the Committee noted a number of minor formatting points appropriate for correction on publication.

LC922 The Animal Gathering (Wales) Order 2004

Considered by the Legislation Committee on: 22<sup>nd</sup> June 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: in the Welsh text: the enabling powers should be referred to as "adrannau 1, 7, 8 ac 83"; article 2, article 7(1), article 12, article 2 of the English text contained drafting defects; the paragraph 2(3) of the Schedule, Schedule, sub-paragraphs (a) to (d) contained inconsistencies between the English and Welsh texts. Under Observations the Committee noted that articles 8(1) and 9(1) contained inconsistencies between the English and Welsh texts; the English text of paragraph 2(a) of the Schedule contained some gender-specific language; paragraph 3 of the Schedule contained a grammatical error. The Committee also noted some formatting points appropriate for correction on publication.

LC923 The Education (School Teachers' Qualifications) (Wales)
Regulations 2004

Considered by the Legislation Committee on: 29th June 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: paragraph 5 in regulation 6 should be deleted whilst paragraph 8 of Schedule 2 should be included in regulation 6(5). Under Observations the Committee noted that the definition of defines "teaching" and "to teach" in regulation 3 could have no effect until coming into force of the Education (Specified Work and Registration) (Wales) Regulations 2004. The Committee also noted some formatting points appropriate for correction on publication.

LC924 The Education (Specified Work and Registration) (Wales)
Regulations 2004

Considered by the Legislation Committee on: 29th June 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: Paragraph 3 of Schedule 2 contained inconsistencies between the English and Welsh texts and needed further clarification. Under Observations the Committee noted that in paragraph 2 of Schedule 2 the use of "were employed" would have been more appropriate. The Committee also noted some formatting points appropriate for correction on publication.

LC925 The School Teachers (Consequential Amendments) (Wales)
Regulations 2004

Considered by the Legislation Committee on: 29th June 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted some formatting points appropriate for correction on publication.

LC926 The Wildlife and Countryside Act 1981 (Amendment) (Wales)
Regulations 2004

Considered by the Legislation Committee on: 29<sup>th</sup> June 2004

The Committee did not identify any points reportable under S.O.11.7.

LC927 The Conservation (Natural Habitats, &c.) (Amendment) (Wales) Regulations 2004

This Statutory Instrument was withdrawn from the Legislative process.

Considered by the Legislation Committee on: 29th June 2004

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: the introductory paragraph setting out the powers under which the Regulations were made, regulation 5, regulation 6 contained drafting defects. Under Observations the Committee noted a number of minor formatting points appropriate for correction on printing.

LC934 The Bus Service Operators Grant (Amendment) (Wales) Regulations 2004

Considered by the Legislation Committee on: 6th July 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that a few minor points identified in relation to an earlier draft were correct in the laid version.

LC935 The Planning and Compulsory Purchase Act 2004 (Commencement No. 2) (Wales) Order 2004

Considered by the Legislation Committee on: 6th July 2004

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted some minor points in relation to the Explanatory Note and footnotes suitable for correction on publication.

The Committee did not identify any points reportable under S.O.11.7.

The Committee did not identify any points reportable under S.O.11.7. Under Observations the Committee noted that some formatting points that had been identified previously to the drafting lawyer had been corrected.

The Committee identified several points reportable under S.O.11.7 to which it drew special attention of the Assembly. The points were appropriate for correction by means of a Memorandum of Corrections under S.O.24.13: regulation 1, regulation 2 contained inconsistencies between the English and

Welsh texts; regulation 4 contained a drafting defect. Under Observations the Committee noted that these Regulations used the Welsh term "archwilydd" for "inspector" whereas the more commonly used term in these circumstances was "arolygydd". The Committee was informed that a decision had been taken to use the term "arolygydd" in all future legislation. The Committee also noted some formatting points appropriate for correction on publication.
