Derbyniwyd ateb i'w gyhoeddi ar 22 Mawrth 2012 Answer received for publication on 22 March 2012 **The Minister for Housing, Regeneration and Heritage (Huw Lewis):** The Welsh Government is committed to combating homelessness and its impact on all people as set out in our Ten Year Homelessness Plan, which recognises the vulnerability of young people and their need for support. This year, the Welsh Government has invested £7.3 million on Homelessness Grant and £139.2 million on Supporting People funding.

The Supporting People programme is focussed on the prevention of homelessness and helping people who are establishing their independence following a period of homelessness, including young people. Examples of the types of support provided include tenancy and independent living skills, managing personal finances, engaging with health and substance misuse services, addressing behavioural issues and connecting with training and employment opportunities.

We are now developing a new framework for implementing Supporting People which provides for better strategic planning at local, regional and national level, with a stronger focus on outcomes. This will enable improved application of this funding to support homeless young people.

I will be bringing forward proposals for legislation on homelessness in our Housing Bill. We are also supporting young people through our Homelessness Grant programme, including a range of projects which help them move away from rough sleeping and into settled accommodation.

Huw Lewis: Our Ten Year Homelessness Plan sets out our long term direction for preventing homelessness, and places a priority on helping young people avoid homelessness.

We are implementing this plan through funding, guidance, promoting good practice and legislation.

The foundation for prevention is housing advice, and we are providing £900,000 to fund a network of housing advice services which helps many young people. We are funding the Shelter Cymru youth homelessness education service, which promotes learning in schools and other youth settings. A film we funded on youth homelessness was recently shown on BBC, and is being distributed with a teaching pack to schools.

Our Homelessness Grant programme funds a wide range of other youth projects, including family mediation services which help young people to reconnect with families, and short term provision such as shelters and respite housing. We have issued guidance for local authority social services and housing on joint working to prevent youth homelessness, and we are now providing support for local authorities to implement this guidance.

Vulnerable young people are already protected by homelessness legislation. We are reviewing current homelessness legislation and aim to introduce changes which strengthen the focus on prevention.
