The work is on schedule to be completed before the recommended deadline in the Working Smarter report of July 2013.

**John Griffiths:** The Countryside Code produced by the Countryside Council for Wales (CCW) provides clear guidelines for keeping dogs under control.

The Code is supplemented by other guidance found in "Out in the Country – Where you can go and what you can do", "You and Your Dog in the Countryside" both published by CCW; advice provided by the Kennel Club on its website; and guidance issued by the Health and Safety Executive on "Cattle and public access in England and Wales".

The control of dogs is the responsibility of their owners. The responsible control of dogs will be examined in the development of the Control of Dogs Bill recently announced by the First Minister.

**John Griffiths:** Breeding bird numbers are assessed annually in the UK by a number of organisations under the auspices of the Breeding Bird Survey. Of the 53 bird species in Wales for which trends can be calculated, seven have declined significantly, and 17 increased significantly, since the start of the survey in 1994.

Through its leadership role in the Wales Biodiversity Partnership, Welsh Government draws together experts from the statutory agencies, local authorities, and third sector organisations such as RSPB, to help determine and define priorities for nature.

On 10 July I signed new legislation which clarifies and improves the UK's transposition of the Wild Birds Directive. The regulations place duties on relevant authorities to ensure steps are taken to protect and create bird habitat. Subject to Assembly approval the legislation is due to come in to force in late August.
