Dear Assembly Member

I am writing to provide you with an update regarding our Safe Routes to Trunk Road Schools programme.

Last year I announced that I had allocated over £500,000 to implement a programme of part-time 20mph speed limits at eight schools in Wales. Implementation of the advisory speed limits has now been completed and we are preparing to consult on permanent traffic orders.

We have now identified 41 additional schools where part-time 20mph speed limits can be implemented as part of a three year rolling programme. I have announced a £4.5 million three-year programme for this work.

A summary of the three year programme is set out in the annex to this letter.
