The Minister for Health and Social Services (Lesley Griffiths): Preventing avoidable harm, including reducing avoidable mortality is a key priority of the NHS in Wales. Mortality in hospital is a tier 1 indicator within the Annual Quality Framework and is currently monitored monthly at Local Health Board (LHB) level. This is reported locally by LHB Boards and is therefore publically available. However I have asked my officials to publish this on all-Wales basis. I will write to you as soon as this is available.

The Minister for Local Government and Communities (Carl Sargeant): The replacement passenger footbridge is part of a package of improvements that is being taken forward by Network Rail under the UK Government's "Access for All" programme for England and Wales. The project is scheduled to be completed at the end of this year.
