Roedd gan Lywodraeth Cymru Barth Sgiliau newydd eleni a oedd gyferbyn â'r Neuadd Fwyd. Nod y Parth oedd dangos i'r plant a'r bobl ifanc a oedd yn ymweld â'r Sioe yr holl yrfaeodd amrywiol sydd ar gael o fewn y diwydiant bwyd a diod. Roedd brand Bwyd a Diod Cymru i'w weld yn glir y tu mewn a'r tu allan i'r Parth Sgiliau.

In agreement with the Royal Welsh Agricultural Show committee, and the management team, the only branding in and around the Food Hall in this year's show was Food and Drink Wales / Bwyd a Diod Cymru. This was displayed prominently throughout.

This year the Welsh Government had a new Skills Zone adjacent to the Food Hall. The aim of the Zone was to demonstrate to children and young people visiting the Royal Welsh Show the variety of careers available in the food and drink industry. The Skills Zone was also branded internally and externally with Food and Drink Wales / Bwyd a Diod Cymru.
