This Order provides for the dissolution on 1st April 2003 of the Powys Health Care National Health Service Trust established on 16 November 1992.

In exercise of the powers conferred by section 126(3) of the National Health Service Act 1977(1) and section 5(1), and paragraph 29(1) of Schedule 2 to the National Health Service and Community Care Act 1990(2) and now vested in the National Assembly for Wales(3), the National Assembly for Wales considering it appropriate in the interests of the health service to make this Order(4), and after completion of the consultation period prescribed under paragraph 29(3) of Schedule 2 to the latter Act(5), hereby makes the following Order:

**Title and commencement**

**1.**—(1) This Order may be cited as the Powys Health Care National Health Service Trust (Dissolution) Order 2003.

(2) This Order shall come into force on 1<sup>st</sup> April 2003.
