MEMORANDUM OF CORRECTIONS LAID BEFORE THE ASSEMBLY UNDER STANDING ORDER 22.13

The Children (Protection from Offenders)
(Amendment) (Wales) Regulations 2001

Background

The Regulations to which this memorandum relate were laid before the Assembly on 13th June 2001, considered by the Business Committee on 26th June 2001 and by the Legislation Committee on 3rd July 2001.

The report of the Legislation Committee about the Regulations identified certain matters, being typographical errors, as appropriate for correction under Standing Order 22.13.

The following amendments rectify those errors:-

Regulation 2

Amendment 1: renumber the second Regulation of the English text, substituting "2" for "3".

Reason for the amendment: typographical error.

Amendment 2: in sub-paragraph (b) of paragraph (2) of the Welsh text substitute "1885" for "1985" and substitute "1985" for

"1985" a rhoddwch "1985" yn lle "1885".
