Edwina Hart: This information is commercially confidential. The international sports event industry is highly competitive with cities and countries bidding against each other for the right to host events. Release of this information would compromise Wales' position in bidding for future major sailing events as it would give an unfair advantage to competing cities and they would be able to adjust their bids to better represent themselves. Also, international event owners expect confidentiality when dealing with prospective host venues and release of this information could prejudice future relations.
