

Signed Petition - 20MPH

Request for Information.

Thank you for your request received on 13 October in which you asked:

Almost half a million people signed a petition for the 20Mph to be disbanded (which is more than the Labour government got in votes)

- 1. When will it be discussed in the Senedd?
- 2. with relevant supporting documentation including the full cost of the exercise.

Please find our response below.

1. When will it be discussed in the Senedd?

The petition We want the Welsh Government to rescind and remove the disastrous **20mph law - Petitions (senedd.wales)** is currently collecting signatures and is due to close on 13 March 2024. The website states that petitions can collect signatures for a maximum of six months.

The petitioner has been contacted to ask whether he wishes to close the petition to enable the petition to be considered by the Petitions Committee sooner. (It is our practice to discuss petitions once they are closed to new signatures). This is a matter for the petitioner, who wishes to continue collecting signatures. Once the petition closes, it will be considered by the Petitions Committee, who will discuss whether the best course of action is to request a debate in the Senedd or take alternative action.

Every petition collecting over 10,000 supporters is considered for a debate.

There is no specific timeframe for this.

2. with relevant supporting documentation including the full cost of the exercise.

Supporting documentation

Before a Committee discusses a petition, they normally seek a written response from the Minister, and a **briefing** from the Senedd Research Service. These would be published to inform the discussion.

There are four briefings related to this petition:

- i. 20mph in Wales: implementation and effectiveness (senedd.wales)
- ii. 20mph in Wales: enforcement and monitoring (senedd.wales)
- **iii.** Reallocate the £30m being used for 20mph limits, to the NHS which is in crisis, especially BCUHB!
- iv. Exempt A and B roads in Wales from the proposed blanket 20mph speed limit.

As this information is already available, your request is subject to section 21 of the Freedom of Information Act 2000 (FOIA) which exempts information that is already reasonably accessible by other means.
