# **Conservative Party nominated debate**

**NDM937** 

- 1. The National Assembly acknowledges the growing pressures facing social services in Wales and notes with particular concern:
  - a. The accelerating decline in the number of residential and nursing home places in Wales;
  - b. The inadequate level of the fees paid to residential and nursing homes in the independent sector compared to the level of funding given by Local Authorities to their own care homes;
  - c. The high and increasing number of assessments that do not lead to the provision of community care services;

- d. The difficulties in recruiting and retaining staff in the social care sector, and especially in children's services;
- e. The decline in the numbers applying for social work qualifying training.

## 2. The National Assembly recognises the need to:

- a. Raise the level of fees paid to residential and nursing homes in the independent sector;
- b. Increase the proportion of assessments that lead to the provision of community care services;
- c. Value and support the social care workforce in Wales;
- d. Allocate sufficient funds to help facilitate higher standards and better quality in the social care sector.

# The following amendments were tabled: Amendment 1 - Andrew Davies (Swansea West)

In point 1 delete all after "services in Wales" and replace with;

- " and their importance in supporting vulnerable people. It recognises the important contribution of the independent care sector and therefore welcomes the action which the Assembly is taking, working in partnership with that sector, the voluntary sector, local government and others to:
- a) promote higher quality and standards through national minimum standards, regulation and consistent, independent inspection through the Care Standards Inspectorate for Wales;
- b) support the development of the social care workforce in the light of the Chief Social Services' Inspector's Report;
- c) develop revised statutory guidance on the commissioning of social care;
- d) support measures to tackle delayed transfer of care and to provide greater stability to the care home sector through the provision of £5m in 2001-2 and 2002-3; and
- e) maintain a constructive and open dialogue about issues of joint concern through regular meetings between the Minister for Health and Social Services and representatives of the independent care sector. "
