Mae'r Cynulliad hwn yn credu y dylid talu iawndal i hemoffiligion sydd wedi'u heintio â Hepatitis C a HIV o ganlyniad i dderbyn cynnrych gwaed heintiedig. Dylai'r iawndal hwn fod ar ben yr hyn a delir i'r rheini sydd wedi'u heintio â HIV oherwydd y cymhlethdod a'r dioddefaint ychwanegol a achosir i'r rheini sy'n dioddef o HIV sydd hefyd wedi'u heintio â Hepatitis C.

This Assembly believes that compensation should be granted to haemophiliacs who have been doubly infected with Hepatitis C and HIV as a result of receiving infected blood products. This compensation should be in addition to that granted for HIV infection because of the complication and further suffering caused to HIV sufferers who have also been infected with Hepatitis C.
