Plaid Cymru Party nominated debate

NDM2226 Jocelyn Davies (South Wales East)

To propose that the National Assembly of Wales:

Deplores the failure of the Government to intervene in the housing crisis.

The following amendments were tabled:

Amendment 1 - Jocelyn Davies (South Wales East)

Delete all and replace with:

- 1. Acknowledges that an adequate supply of affordable housing is essential in a civilised society and calls on the Labour Assembly Government to:
- a. grant local authorities the power not to implement the Right to Buy scheme;
- b. establish a Community Land Trust Unit with its own budget;
- c. grant local authorities the power to demand that there are affordable homes in all new developments of more than 10 houses.

Amendment 2 - Kirsty Williams (Brecon and Radnorshire)

Add new point at end of motion:

Calls for the development of a Welsh Home Improvement Lending Agency to help elderly homeowners and others release equity in their homes in order to improve them.

Amendment 3 - Kirsty Williams (Brecon and Radnorshire)

Add new point at end of motion:

Calls on the Assembly Government to invest more in new social housing in areas of high demand.

Amendment 4 - Kirsty Williams (Brecon and Radnorshire)

Add new point at end of motion:

Recognises that although the Homebuy scheme has made a significant contribution to providing affordable housing, it has done so by eating into the money available to build new homes for rent. Accordingly, this Assembly calls on the Government to establish a separate Homebuy budget line in addition to the existing resources available for Social Housing Grant.

Amendment 5 - Kirsty Williams (Brecon and Radnorshire)

Add new point at end of motion:

Recognises that homelessness is best tackled at a local level and calls for more effective local homelessness strategies supported by Welsh Assembly Government investment.

Calls for restrictions on the right to buy in areas of high demand.

Requires the Welsh Assembly Government to ensure that all local authorities carry out local housing needs surveys and recognises the need for Planning Authorities to undertake surveys on a community level in order to establish local housing needs.

Recognises the vital importance of creating a parity of esteem between vocational and academic qualifications in order to meet Wales' needs.

Add as new point at end of motion:

Supports young people who are continuing in education and directs the Labour Assembly Government to create a Special Grant, to be administered in the same way as the Educational Maintenance Allowance, extending the right to apply for financial assistance to those who reach their 18th Birthday during the academic year 2004/05.

Condemns the Labour Assembly Government for presenting an action plan that does not accord with its own language policy and fails to meet the obligation to ensure the equal status of Welsh and English across all sectors.

Recognises that the allocated budget to develop Basic Skills support is insufficient and instructs the Labour Assembly Government to review funding as a matter of urgency.

Add as new bullet point at end of motion:

Calls on the Labour Assembly Government to commit to a system of funding post -16 education which

will not act as a financial deterrent to students and confirms that a system which includes Student Top up Fees is not acceptable in Wales.
