The Minister for Health and Social Services (Mark Drakeford): Cystic Fibrosis care for North Wales patients is not affected by the re-organisation of Betsi Cadwaladr Health Board. A Wales Cystic Fibrosis review coordinated by the Welsh Health Specialist Services Committee is nearing completion and its recommendations will be considered by them in July.

The Minister for Natural Resources and Food (Alun Davies): To date, trees have been felled at 128 locations in Wales covering a total of 1,338 hectares to control the spread of *Phytophthora ramorum*. Information on numbers of trees felled has not been collected. These fellings were to meet statutory notice deadlines ranging from 31/03/11 to 31/08/13. Of the 128 sites, 111 were felled by Natural Resources Wales (previously by Forestry Commission), 17 were felled by other land managers including private owners and the National Trust.
