Health Commission Wales (HCW) and the 3 regional Cardiac Networks have agreed an all Wales strategic development plan for arrhythmia services, which includes plans to improve the rate of access to ICDs. This will help address the needs of the population of South Wales Central. The £2.550m central funding I have provided to support the strategic development plan will be allocated to the 7 LHBs from 2010-11 and I expect them to continue to implement the plan.

**Chris Franks (South Wales Central):** Will the Minister make a statement regarding the performance issues of Cardiff and Vale University Health Board. (WAQ55655)

#### Answer issued on 24 February 2010

Performance is routinely monitored by Welsh Assembly Government officials and monthly meetings are held between the Director of Operations and the LHB to discuss and address any issues. In addition, the Chief Executive of the NHS meets the Chief Executives of all LHBs collectively to address performance and in turn, I meet the Chairs to ensure that they are well aware of any performance issues.

From the recent statistical release you will have seen that Cardiff and Vale University LHB achieved the referral to treatment waiting times in December 2009, where 99.8% of patients were waiting less than 26 weeks for treatment and no one was waiting longer than 36 weeks.

# Answer issued on 24 February 2010

In delivering the Strategic Action Plan for the Welsh Dairy Industry, the Welsh Assembly Government last year provided funding to commission work to look at potential opportunities for Added Value Dairy products in the key categories for the industry; namely, yogurt, chilled desserts, ice-cream, cheese, flavoured milk, and butter. The combined value of all added value dairy sectors in the UK is £6.2 bn. This research identified a number of opportunities which the Welsh Dairy Industry could potentially exploit. The Welsh Assembly Government is now keen that Welsh companies benefit from this research and develop new products for the market.

To ensure the industry takes advantage of this information a support programme has been developed. The 'Added Value Dairy programme' has been developed to support companies with a comprehensive support package including information on understanding the UK Retailer Market, support and guidance to develop marketing plans and an insight into developing presentations to buyers and training in negotiation skills.

It will be important from the outset that the companies are confident that the retailers/foodservice operators will be open to new product concepts from Welsh suppliers. It is therefore proposed to undertake trade interviews with the head of dairy in each of the major retailers. This will ensure that a clear understanding of their national and regional (i.e. Welsh) strategies is obtained, while at the same time, getting their support for the programme and a commitment to work with Welsh suppliers on an ongoing basis.

Nine companies are engaging in this tailor made programme of support which starts next week (24th February 2010.)

In addition to this specific programme a total of  $\pounds 2.5m$  grant aid has been approved for the Dairy Industry in Wales since 2007, enabling a total investment in the sector of  $\pounds 6.5$  million. Other Government support for processors is currently available under the Rural Development Plan for Wales 2007-2013 in the form of the Processing and Marketing Grant scheme and the Supply Chain Efficiencies project. The True Taste Awards, has also been an excellent driver in emphasising Wales as a producer of high quality and innovative produce, and is recognised by consumers and the food and drink industry as a sign of excellence.

The Welsh Dairy industry is ideally suited to milk production with predominance of grass-fed systems, climate, topography and water resources all supporting dairy production. I am therefore keen to see Wales process more of what we eat, particularly added value dairy products and I trust the market intelligence information obtained and Added Value Dairy programme will be embraced by the industry and result in a number of new and exciting products being developed.
