NDM710 To propose that the Assembly:

1. Notes the 2000 – 2001 Annual Report of the European Affairs Committee which was laid in the Table Office on 18 June 2001;

2. Recognises the significant progress made in strengthening Wales' relationship with the European Union and its institutions by the increased participation of Assembly Ministers in the Council of Ministers, the role of the Assembly's office in Brussels and the recent decision to join the Conference of Peripheral and Maritime Regions;

3. Notes the progress made in implementing European Structural Funds programmes in Wales;

4. Calls upon the Assembly Cabinet to consider the impact on Wales of the key issues of enlargement of the European Union, future cohesion policy and European governance and take all necessary steps to ensure that Welsh interests are recognised;

Calls upon the Assembly Cabinet to take up the opportunity to influence The debate on the enlargement of the European Union, future Cohesion Policy and European Governance by ensuring that the Assembly's views are presented in all available fora in a timely and consistent manner;

Add as new point at the end of the motion Calls for the European Affairs Committee to be given a clearly defined scrutiny role;

Regrets the fact that the First Minister did not sign the political declaration by the Governments of Bavaria, Catalonia, North-Rhine Westphalia, Salzburg, Scotland, Wallonia and Flanders on the future of the European Union (28th of May 2001).
