The Minister for Education and Skills (Leighton Andrews): It is intended that the regulations detailing the provisions for mandatory governor training should come into force in September 2012. Not all governor training will become mandatory at that time. I have chosen areas that I believe will have the most impact on raising standards for governance. These areas will be induction training for newly appointed and elected governors, training for chairs and training for governors on the use and understanding of school performance data.

The induction training will focus on governors' roles and parameters of their.

Whilst there may be some minor increase in costs for local authorities, these should be minimal, bearing in mind that the Welsh Government will be producing training programmes for local authorities to use free of charge. If local authorities chose to amend their own existing programmes there could be some staff time costs relating to this which should be absorbed in the normal way. Local authorities will be expected to work together through consortia and collaboration arrangements to deal with any capacity issues regarding the training.

John Griffiths: Due to current financial pressures, and an overall reduction in capital funding available, the discretionary Contaminated Land Capital Projects Funding Programme was withdrawn in April 2011. This funding programme was established in 2005 to assist local authorities in the discharge of their statutory duties under Part 2A of the Environmental Protection Act 1990. This was in addition to the £2M already provided to local authorities via the Revenue Support Grant which continues to provide support. The underlying principle of the contaminated land regime is that the polluter pays and the cessation of capital funding does not affect this.

Carl Sargeant: Following a request from the community council and the local County Councillor, Welsh Government consulted with statutory consultees on proposals to restrict parking on sections of the A487 trunk road in Tre Taliesin. The purpose of the proposal is to remove parking from areas where it may compromise road safety.

At the current time no provision has been made to retain the parking facilities for the residents of Tre Taliesin. However, we will raise their concerns with Ceredigion County Council who are the parking authority.
