**Lesley Griffiths:** In order to address the issues of both self harm and suicide, the Welsh Government launched Talk to Me, the National Action Plan to reduce Suicide and Self Harm in November 2009. The Plan consolidates Welsh policy, builds upon progress made in line with the mental health National Service Frameworks for Adults and Children, and reflects evidence from across the UK and elsewhere. "Talk to Me" identifies the low ratio of self harm to suicide in older people and the need therefore for such incidents of self harm to be rigorously addressed.

In Wales we have a national suicide and self harm advisory group chaired by Public Health Wales and a Clinical Research Group focused on suicide and self harm, providing advice and high quality research to Welsh Government. In addition, the National Institute for Clinical Excellence has produced clinical guidelines on the treatment of self harm. In treating people who self-harm, both the physical injuries of self-harm and the underlying emotional causes need to be addressed.

**Lesley Griffiths:** There is a current national outbreak of whooping cough (pertussis) in the UK, the largest seen in the UK for over a decade. There has been a total of 4,791 cases to the end of August 2012 in England and Wales. Most cases have been in adolescents and young adults, however, there have been 302 cases in infants less than three months of age, with 9 deaths to August 2012 (none in Wales).

The Joint Committee on Vaccination and Immunisation (JCVI), the UK's independent, vaccine advisory panel has recommended a temporary programme for the immunisation of pregnant women against whooping cough to protect their newborn infants.

It is recognised introducing a vaccination programme for pregnant women will not reduce transmission of pertussis in the community. The intention of the programme is to increase protection to newborn infants who are most at risk by providing passive immunity through the mother. The effectiveness of vaccinating newborn babies directly is uncertain and not recommended. Infants should still be immunised in accordance with the routine childhood immunisation schedule at 8, 12 and 16 weeks.

Immunisation will be offered, ideally at a routine antenatal visit, to women from 28 weeks of pregnancy.

There is no single whooping cough vaccine available. It is proposed to offer the vaccine Repevax which contains a low dose of diphtheria, tetanus and polio along with the pertussis vaccine. JCVI has advised that it is satisfied with safety implications for pregnant women.

We are introducing the vaccination programme for pregnant women in Wales in line with the other three UK countries, initially for six months. The outbreak will be monitored and consideration will be given to extending the programme if required.

The Minister for Local Government and Communities (Carl Sargeant): The Welsh Government finds the abuse and neglect of children totally unacceptable. Safeguarding children from any kind of abuse is everyone's responsibility. The Welsh Government has clearly set out how all agencies must work together to safeguard and promote children's welfare and protect them from harm in statutory guidance entitled Safeguarding Children: Working Together Under the Children Act 2004."

The Welsh Government, through the Right to be Safe strategy recognises that children are directly and indirectly affected by domestic abuse.

We have funded Welsh Women's Aid groups throughout Wales to provide support directly to children who have experienced or are experiencing domestic abuse. We have also taken action by supporting the Black Association of Women Step Out (BAWSO) to provide a children's worker and an outreach worker for specialist and holistic support to children from BME communities.

For children and young people who have experienced sexual abuse, funding has been provided to New Pathways to provide specialist counselling and support services.

We have also, as a result of the strategy, supported the delivery of education and awareness to prevent violence against women and domestic abuse. In particular, our 'Live fear free' campaign last December raised awareness of the impact that domestic abuse has on children. With over 33,000 views between them so far, the Live Fear Free campaign videos are in the top five most viewed videos on the Welsh Government website.

To consolidate this work we have also raised awareness amongst young people by:

- Part funding of the Spectrum Schools programme provided by Tai Hafan to educate young people Wales about domestic abuse and its consequences
- Financially supporting the NSPCC Caring Dads programme which is for men who are at risk of becoming perpetrators of domestic violence and of causing harm to their children.

**Carl Sargeant:** The 10,000 Safer Lives project is a programme for government priority that aims to ensure all relevant service providers and organisations are able to identify the signs of domestic abuse and are able to effectively support individuals who experience domestic abuse.

Eleven minimum standards have been identified, drawn from effective practices across Wales, which together can make a real difference to the quality of services experienced by victims of domestic abuse and would provide confidence that the service they can expect will be of a certain standard.

The project found that it is particularly important for public services to get the first point of contact right and to make sure frontline staff can be confident in taking action. A set of "five questions to save a life" that frontline staff can easily refer to has been produced.

The findings of the project were fully strongly supported by the Public Service Leadership Group which has undertaken to ensure quick and widespread adoption. The regional leads on the Public Service Leadership Group, who are drawn from across the public service, are currently assessing the public service within their region against the minimum standards.

I have also written to the Chairs of LSBs to ensure that all LSBs, as well as regional leadership groups, respond to this challenge. From this local and regional analysis we will be able to identify any common issues/barriers across Wales/priority areas for action.

The emerging likely areas for action include (1) the dissemination of good practice to ensure the consistent application of risk assessment, (2) clarification of when it is appropriate to share information to build confidence in front line staff (3) support for the implementation of successful workplace policies, including exploring a web based mechanism for helping managers and (4) the development of a consistent all Wales approach to training.
