2009 - 20

2010 - 27

2011 - 10

This data is derived from the Welsh Government's Request for Information Tracking System. This system produces statistics relating to the handling of requests for recorded information under the FOIA, the DPA and the Environmental Information Regulations 2004 (EIRs). It is not possible to separate the requests into one access regime only. This is because one single request can include questions which fall under more than one regime. For example, a requestor may have made a request which includes a series of questions some of which must be processed in line with the Freedom of Information Act and others the Data Protection Act.

**The Minister for Health and Social Services (Lesley Griffiths):** When considering whether new medicines such as eculizumab (Soliris) should be routinely available to patients in Wales, the Welsh Government is guided by recommendations from the National Institute for Health and Clinical Excellence (NICE) and the All Wales Medicines Strategy Group (AWMSG), two highly respected bodies.

In this particular case, the manufacturer/ holder of the marketing authorisation for eculizumab (Soliris) has, despite requests, failed to submit evidence of clinical and cost effectiveness for appraisal by AWMSG. It has therefore not been possible for this new indication to be appraised. On that basis, AWMSG cannot endorse its' use within NHS Wales for the treatment of patients with atypical haemolytic uraemic syndrome .

Where a new medicine or new indication has not been endorsed by AWMSG or NICE, clinicians can make an application to their Health Board to fund through the Individual Patient Funding Request (IPFR) process. This will require the patient's clinician to demonstrate need based on exceptionality. A copy of the IPFR information leaflet is attached.

**Lesley Griffiths:** Registered nurses are required by the Nursing and Midwifery Council to undertake Post Registration Education and Practice (PREP) in order to maintain their registration. Registered nurses and nursing support staff should undertake a formal appraisal each year to identify continuing professional development needs and how they can be achieved. The Welsh Government Workforce and Organisational Development strategy emphasises the importance of appraisal. Continuing professional development can be undertaken in a variety of formats including work based learning, reflective practice and private study as well as more formal conferences and study events.

The Welsh Government expects all employers of registered nurses to monitor and facilitate the completion of continuing professional development. Responsibility for funding continuing professional development lies with employers.

The Welsh Government does not collate information on this expenditure.

The Minister for Housing, Regeneration and Heritage (Huw Lewis): Rhondda Life Limited (RLL) is a company limited by guarantee, comprising three independent organisations: Ferndale Rugby Club, Cor Meibion Morlais (Morlais Male Choir) and Blaenllechau Community Regeneration (BCR). RLL was established as a social enterprise to coordinate activities for development and regeneration of the locality. Since 2009, a total of £1.844m has been invested by the Welsh Government in RLL and the three member organisations. RLL has reported that it has trained 24 people experiencing barriers to employment, it has employed 14 people, and it has the potential to create up to 35 jobs over time.

RLL and its member organisations have been subject to routine monitoring procedures linked to Welsh Government grant funding. Our procedures are well-established, but we review them regularly.

In November 2011, officials were made aware by the Board of RLL of a further funding requirement relating to the first phase of the company's development plan: the Glynrhedyn Centre. A series of meetings has subsequently been held to explore potential funding opportunities. The nature and content of these discussions is commercially confidential at this time.

Although the future plans and governance of the company are ultimately a matter for its Board, the Welsh Government is, as per usual project appraisal practice, seeking assurances about RLL's business plan and performance to date before we consider any funding offer.
