**MEMORANDUM OF CORRECTIONS LAID BEFORE THE
ASSEMBLY UNDER STANDING ORDER 22.13**

The Smoke Control Areas (Authorised Fuels)(Wales) Regulations 2001

Background

The Regulations, to which this memorandum relates, were laid before the Assembly on 1st October 2001, considered by Business Committee on 16th October 2001 and by the Legislation Committee on 30th October 2001.

The report of the Legislation Committee about the Regulations identified certain matters, being grammatical and typographical errors, as appropriate for correction under Standing Order 22.13.

The following amendments rectify those errors:-

Heading

Amendment 1: in the both texts insert the Commencement Date as 17 Rhagfyr 2001 and 17th December 2001

Reason for the amendment: grammatical and typographical errors.

Regulation 3

Amendment 2: in the both texts in paragraph (2) remove the square brackets from around the words "17 Rhagfyr 2001" and "17 December 2001"

Reason for the amendment: grammatical and typographical error.

Schedule 1

Amendment 3: in both texts in paragraph 3 sub-paragraph (a) should commence in the lower case

Reason for the amendment: grammatical and typographical error.

Amendment 4: in the Welsh text in paragraph 5 replace "Ireland" with "Iwerddon"

Reason for the amendment: grammatical and typographical error.
