REVISED BUDGETS FOR 1999-2000 RESULTING FROM TRANSFER CHANGES FOR MAIN EXPENDITURE GROUPS

EXPLANATORY NOTE

[This is not part of the motion]

In accordance with Standing Order 19.7, the motion asks the Assembly to approve the transfers across main expenditure groups for the current financial year. It is normal procedure for transfers to take place during the year across main expenditure groups, largely due to administrative changes. For example, the current transfers include provision for the transfer of responsibility of Techniquest from Cardiff Bay Development Corporation to the National Assembly Education Department. All of the transfers shown were agreed by the Secretary of State prior to the transfer of functions on 1 July 1999. The Assembly is asked to approve the changes on this basis.

It is possible that prior to laying this motion the Finance Secretary will make a statement on the allocation of additional funds from the Winter Supplementary Estimate, and on transfers between sub expenditure groups. More information about this will be made available to members in due course.
